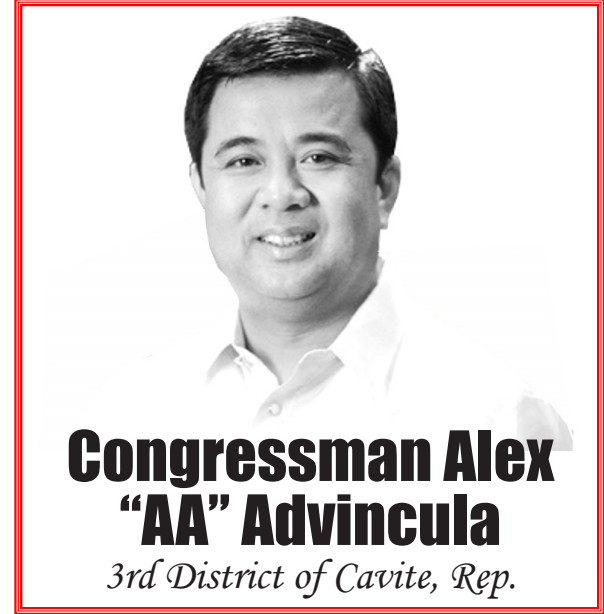

## PRESIDENT DUTERTE APPEALS ARBITRAL RULING VS. CHINA



President Rodrigo Duterte appealed on Wednesday, September 23, the country's arbitral victory in 2016 against China's pursuit in the

South China Sea. Duterte stated in his speech at the United Nations (UN) General Assembly that the country revoked any attempt to

discredit the ruling of the Permanent Court of Arbitration in July 2016.

"The Award is now part of international law, beyond compromise and beyond the reach of passing governments to dilute, diminish or abandon. We firmly reject attempts to undermine it," Duterte stated.

"We welcome the increasing number of states that have come in support of the award and what it stands for — the triumph of reason over rashness, of law over disorder, of amity over

ambition. This - as it should - is the majesty of the law,"

# Revilla, nais na doblehin ang bilang ng sick, vacation leaves ng mga nagtatrabaho sa Gobyerno



Nagpasa ng batas panukalang si Senador Ramon "Bong" Revilla Jr., na naghahangad na doblehin ang bilang ng bakasyon at sick leave na ipinagkakaloob sa mga opisyal at empleyado ng gobyerno.

Bukod sa pagdaragdag ng mga leave, ang Senate Bill No. 1821 na ipinasa ni Revilla ay naglalayon na simulan ang pagbibigay ng rehabilitation leave para na hanggang sa anim na buwan.

Kung maisasabatas ang panukalang ito, ang mga nagtatrabaho

sa ilalim ng gobyerno, nasyonal o lokal, government-owned o controlled corporations at mga state universities at colleges, maging kahit anumang kanilang estado sa trabaho, ay may karapatang magkaroon ng 30 araw na bakasyon at 3 araw na sick leave taun-taon na may buong suweldo.

"The 30 days vacation leave shall be inclusive of the three (3) days Special Leave Privilege (SLP) and the five (5) days Forced Leave (FL)," saad sa panukalang batas.

## Hontiveros pressures NBI, DOH to criminally charge hospitals that violate Anti-Hospital deposit law LGUs must actively monitor for violators, senator urges

"It is unjust to ask a dying person to cough up money before even attempting to save his or her life."

This was the remark of Senator Risa Hontiveros, author of the Strengthened Anti-Hospital Deposit Law, as she pressured the Department of Health, local government units (LGU) and law enforcement agencies to actively monitor and enforce sanctions through their regulatory powers on hospitals that violate the law by demanding cash deposits from emergency patients before providing treatment.

"Bakit natin itinataboy ang mga pasyenteng nasa hukay na ang isang paa? Dapat maparusahan ang lumalabag sa batas. Hindi makatarungang may mga pasyenteng namamatay dahil sa kawalan ng pera lalo na sa gitna ng isang health crisis," she said.

Earlier in the pandemic, Hontiveros warned hospitals that non-compliance to the Anti-Hospital Deposit Law will result in hefty fines and even imprisonment. Under the law, hospitals that will demand any form of advance payment as a prerequisite to life-saving treatment will face imprisonment of up to 6 years, and a fine of P1,000,000. This can also lead to the revocation of their licenses to operate. Likewise, errant hospital

employees will face imprisonment of up to two years and 4 months, and a fine of up to 300,000.

The senator welcomed the criminal charges filed by the National Bureau of Investigation (NBI) against two hospitals that refused to admit a pregnant woman without initial deposit in April, leading to her death.

"I hope the NBI, with the assistance of DOH and LGUs, will continue to file criminal charges against similar violators. Hospitals must not get away with these unjust refusals that literally kill our fellow Filipinos," she said.

Hontiveros urged the LGUs to mobilize

their Barangay Health Emergency Response Teams (BHERTs) to "own up to this life-saving responsibility, especially that they have consistently received assistance from the government in all health emergencies, including COVID-19."

"The DOH and LGUs must be vigilant in monitoring hospitals. Kaysa hintayin pa nating ang mga tao ang magsumbong, dapat may mga handang opisyal na laging nagbabantay sa kanila," she said.

"Two people, a mother and her child, died that day, as countless others have because of this selfish



practice. Dapat siguraduhin natin na wala nang magbubuwis ng buhay. Buhay ng mga Pilipino ang dapat unahin kaysa sa kita," she concluded. #####

he went on.

It can be recalled that France, Germany, and the United Kingdom (UK) last week declared to the UN that they revoked China's "historic rights" in the South China Sea.

The UK filed a note verbal to the UN in New York last week, which states that the European nations upheld the arbitral ruling in 2016 between the Philippines and China.

"France, Germany and the United Kingdom also highlight that claims with regard to the exercise of 'historic rights' over the South China Sea waters do not comply with international law and UNCLOS provisions and recall that the arbitral award in the Philippines v. China case dating to 12 July 2016 clearly confirms this point," as written in the note verbale.

Meanwhile, Duterte brought up that geopolitical disputes continued to emerge despite the coronavirus outbreak.

He then called on to cease the ongoing tensions as developing countries would be unable to resist.

"Escalating tensions benefit no one. New flashpoints heighten fears and tend to tear peoples apart," the state chief said.

"When elephants fight, it is the grass that gets trampled flat," he continued.

Duterte further said that one could "only imagine and be aghast at the terrible toll on human life and property that shall be inflicted if the 'word war' [deteriorated] into a real war of nuclear weapons and missiles."

"I therefore call on the stakeholders in the South China Sea, the Korean Peninsula, the Middle East and Africa: if we cannot be friends as yet, then in God's name, let us not hate each other too much," the President appealed.

"I heard it once said, and I say it to myself in complete agreement," he further said. (GOCAVITE)

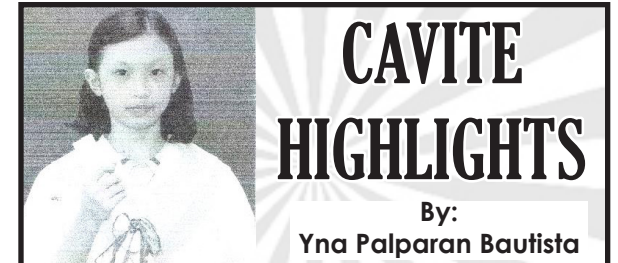



Through this initiative, the public is enabled to report on their individual health condition each time they enter the stores within SM Malls.


Per IATF Resolution No. 45, dated June 10, 2020, a Memorandum of Agreement between Multisys Technology Corporation and the Department of Health (DOH) forged regarding the donation and use of StaySafe.ph, which shall include the source code, all data, data ownership, and intellectual property of Multisys to DOH. Using the app, customers will just have to scan the unique QR code of the store and

rehabilitation leave to government officials and employees who sustained wounds or Injuries while in the performance of their official duties and those whose illness was aggravated due to their working conditions.”

“A review of the current leave laws reveals that there is no law that provides leave benefits and privileges for illnesses of officials and employees acquired or aggravated in the workplace requiring Intensive or longer period of treatment, e.g. cancer,” saad ng explanatory note sa naturang panukalang batas.

“State workers

suffering from this kind of illness or disease need to be provided with reasonable time to go through their treatment. Prolonged illness or sickness consumes the employees’ accumulated leave credits (sick leave and vacation leave credits), most often leaving them on Leave Without Pay (LWOP), if their accumulated leave credits are exhausted,” dagdag pa nito.

**1. Balakubak.** Ang katas at laman ng sariwang dahon ng sabila ay karaniwang gamot para sa balakubak. Ang mga nasabing bahagi ng halaman ay pinampapahid sa apektadong anit.

**2. Paglalagas ng buhok.** Ang katas ng laman ng sabila ay maaari ding gamitin upang maiwasan ang pagkalagas ng buhok at paghantong sa pagkapanot. Ito ay pinapahid lamang sa bahagi ng ulo na may pagnipis ng buhok. Minsan pa, ang katas ng sabila ay hinahalo muna sa alak bago ipahid sa buhok.

**3. Pamamanas.** Maaari namang ipantapal sa bahagi ng katawan na may pamamanas ang dinikdik na dahon ng sabila.

**4. Pagtatae.** Mabisa para sa kondisyon ng pagtatae ang pag-inom sa katas ng sabila na hinalo sa gatas.

**5. Paso.** Ang paso ay maaaring pahiran ng katas mula sa sariwang dahon ng sabila. Makatutulong ito upang maibsan ang hapdi at maiwasan ang pinsala sa balat. Ang katas ay maaari ding ihalo sa langis ng niyog upang mas lalong maging mabisa.


**6. Sugat.** Nakatutulong din sa mas mabilis na paghilom ng sugat ang pagpapahid ng katas ng dahon ng sabila.
