





# CAVITE HIGHLIGHTS By: Yna Palparan Bautista

Severino Lapidario was the leader of the scheduled revolt in Cavite Puerto. Being the Provincial Jail Warden, he would release the prisoners to capture the Spanish infantry.Revolutionists of Kawit, Malabon (Gen.Trias) and Noveleta seized the Spaniards in their towns. Lapidario hesitated and the plan was learned by the Spaniards, so he and twelve others were seized and executed at Plaza De Armas on September 12, 1896. Born in Imus, Cavite, he became a Freemason and a supporter of the aspiration to be free.


