According to DTI region 4A Director Clarke Nebrao, PH's Safety Seal is granted to building and establishments that are compliant with the Minimum Public Health Standards (MPHS), including the adoption and use of accredited contact tracing app. He also added that the initiative is part of the government's efforts to stop the surge of COVID19 while assuring people that the said establishment is safe.

Implementing guidelines of the Safety Seal Program requires enforcement of Minimum Public Health Standards

## DOST-PSTC Cavite conducts TechOpS on mushroom processing for Sustiguer Mushroom Farm workers



The Department of Science and Technology – CALABARZON (DOST-CALABARZON), through its Provincial Science and Technology Center in Cavite (DOST-PSTC Cavite), led a Technology Opportunity Seminar (TechOpS) for the workers of Sustiguer Mushroom Farm in Salawag, Dasmariñas City, Cavite last June 11, 2021. The activity centered on equipping the mushroom farmer-workers of Sustiguer with knowledge and training on sustainable livelihood through mushroom processing. Mushroom scientist Bro. Geronimo Labao was invited to facilitate the TechOpS.

In his welcome remarks, Mr. Eduard Sustiguer of the said Mushroom Farm thanked the participants

for attending the TechOps and the organizers for conducting the event. He likewise expressed his interest for similar trainings and continuous partnership with the agency. These trainings and other entry points for collaboration were reiterated by Mr. Matthew Henry Camitan of the DOST-PSTC Cavite. He elaborated programs and activities that the Sustiguer are eligible to apply for, including the Small Enterprise Technology Upgrading Program (SETUP).

With his 25 years of expertise on mushroom growing, Bro. Labao introduced the participants to the different techniques and ways to produce mushrooms, in particular the use of specially

constructed sheds for mushroom cultivation and to use mushroom cultivation to generate income. He likewise demonstrated a step-by-step procedure on how to farm fresh mushrooms and how to process mushrooms to make various products such as chicharon, empanada, calamares, noodles, and burger patty.

Through the DOST-PSTC Cavite TechOpS, small farming groups in Cavite such as Sustiguer, are equipped with S&T knowledge to maximize the use of their human and material resources for added income, mitigating the adverse economic impact of the pandemic. The blood-letting activity is a continuing advocacy and

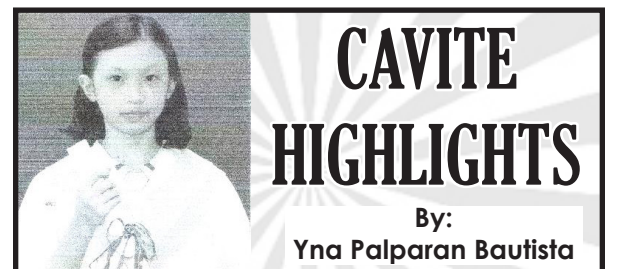
commitment of DOH-CALABARZON to provide safe blood supply and blood products for patients in need of blood transfusion.

## DENR CENRO Calaca pushes for conservation and protection of sea and marine turtles

In celebration of the World Sea Turtle Day, the CENRO Calaca conducted an IEC Lecture on Marine Turtles in Brgy. Mataas na Bayan, Lemery

Batangas last June 18, 2021.

World Sea Turtle Day is celebrated every 16th of June each year to highlight the importance of protecting and conserving the sea turtles or marine turtles. The Philippines is home to 5 of the 7 sea turtle species in the world wherein 4 are classified as Endangered (Green Turtle, Loggerhead Turtle, Leatherback Turtle and Olive Ridley) and 1 is Critically Endangered (Hawksbill Turtle) as listed on the IUCN Red List.

Sea turtles have been

around the earth for 110 million years and have outlived their ancestral dinosaurs and they can live up to 50 to 100 years. However, ocean pollution, turtle egg poaching, hunting for turtle meat are some of the challenges that these majestic and docile creatures face in their lifetime.

This year, the DENR CENRO Calaca through their Conservation and Development Section headed by For. Elizabeth Galit conducted an IEC lecture on the importance of the marine turtle conservation including actual demonstration on

how to properly handle marine turtle eggs until they hatched into saplings for proper release to the Oce9an.

The activity was done in BrgyMataasna Bayan, Lemery, Batangas where there are sightings of marine turtle nesting. It was participated by thePawikan Response Team composed of four Brgys. of Lemery namely: Wawa Ilaya, Wawa Ibaba,

Sambal Ilaya, Sambal Ilaya and residents of BrgyMataasna Bayan, Lemery, headed by Brgy.Captain Ronaldo Ovrador. Continuous intensive Information & Communication (IEC) campaign on Marine Turtle could help save these creatures from near extinction.

(MPHS) such as health declaration and non-contact temperature check on all individual who enters the premises, using of accredited contact tracing app/system, availability of handwashing stations and sanitizers, observance of physical distancing and good ventilation in enclosed areas. Proper wearing of facemask and faceshields as well as regular disinfection and sanitation of high-touch surfaces are also among other requirements.

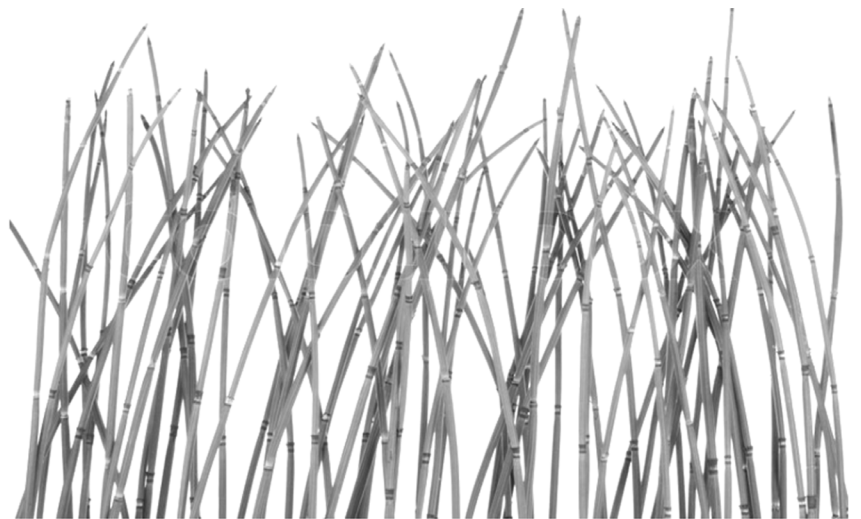
