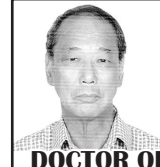

DTI 4-A awards Safety Seal Certification to seven Puregold branches in Batangas

The Department of Trade and Industry Region 4-A awarded Safety Seal Certifications to seven Puregold branches in Batangas: New Market, Batangas City; Calicanto, Batangas City; Lipa City; Rosario; San Juan; City of Sto. Tomas; and Tanauan on June 23, 2021.

The Safety Seal Certification Program is an Inter-Agency Task Force's response to assure the public of establishments' compliance with minimum public health standards and encourage the adoption of the StaySafe.ph digital contact tracing application to strengthen the contact tracing initiative of the

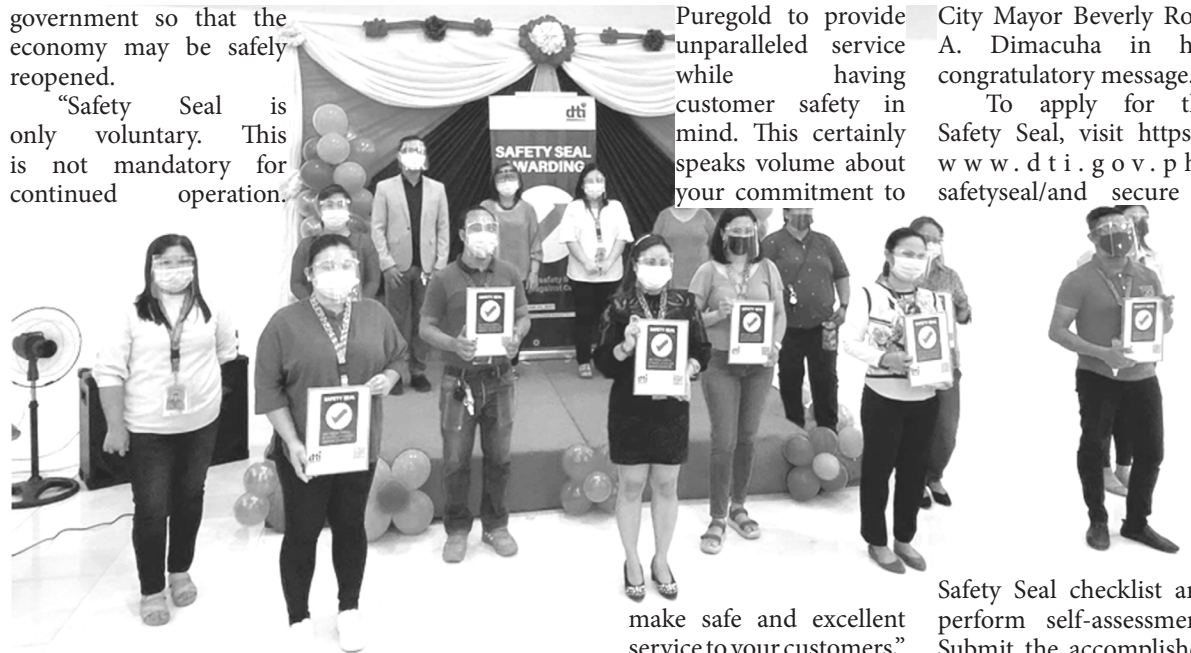
government so that the economy may be safely reopened.

"Safety Seal is only voluntary. This is not mandatory for continued operation.

However, we would like to encourage business establishments to acquire this seal because through this, we, as consumers, and the employees in these establishments are guaranteed that we are safe and protected from COVID-19," said DTI CALABARZON Director Marilou Q. Toledo.

The DTI is the issuing authority of the seal for groceries, supermarkets, membership shopping clubs, convenience stores, construction supply/hardware stores, logistics service providers (outlets), barbershops, salons, and service and repair shops. The safety seal is free; it is renewable and valid for six (6) months from the date of issuance.

According to DTI Batangas OIC-Provincial Director Leila M. Cabreros, applicants need to submit a valid Mayor's permit, compliance with minimum public health standards, and registration with StaySafe.ph to obtain the seal. If the establishment is found non-compliant, the establishment shall be issued with a Notice to Explain (NTE). Failure to comply with the protocols in question in the NTE shall result to the revocation of the Safety Seal.

Meanwhile, Puregold Price Club, Inc. Regional Manager Rita Bianca C. Tacorda promised that these branches will continue to be compliant to keep their certifications.

kabataan. Let's extend these private schools the lifeline they urgently need. Dapat aksyunan na ito ng BIR ngayon," sabi ni Hontiveros.

"Bilang solo mom na nagtustos ng pag-aaral ng aking apat na anak mula sa grade school hanggang sa kolehiyo, alam ko ang hirap ng pagbayad ng tuition fee, at mas lalong mahirap sa panahon ng pandemya. Ang aking pangamba ay kung ganyan kataas ang buwis na ipapataw sa mga paaralan, baka mapasa ito sa mga magulang na nagkakanda kuba na sa mga gastusin ng pang-araw na araw," dagdag ng senador.

Ayon sa COCOPEA, mahalaga na agad na maalisan ang regulasyon dahil ang ilan sa kanilang miyembro ay kinukwestiyon dahil sa pagkuha nila ng

preferential tax rate na 10% batay sa Sec. 27 B ng National Internal Revenue Code. Sinabi din ng samahan na inoobliga ng Legal Division ng ilang mga panrehiyong tanggapan ng BIR ang mga private schools na magpakita ng kopya ng isang desisyon ng BIR na nagkukumpirma na kasama sila sa 10% na tax rate.

"Inaanayahan ko ang BIR na malinaw na mag-isyu ng isang pagpapasya na nagbibigay karapatan sa mga pribadong paaralan sa 10% na preferential tax rate, at ang 1% na tax rate sa loob ng tatlong taon dahil sa pandemya. Malupit na magpataw ng ganito katalim na pagtaas sa gitna ng lumalalim na krisis sa ekonomiya. Sa panahon ngayon, dapat tinutulungan natin silang manatiling buhay,

hindi yung sinisipa pa silang pababa," sabi ni Hontiveros.

Si Hontiveros ay kapwa may-akda ng Senate Bill 2272, na naglalayong malinaw na isama ang mga proprietary institutions sa tax benefit. Gayunman, sinabi ng senadora na pinakamahalaga na kaagad na malinaw ng BIR ang pagsasama ng mga pribadong paaralan sa 10% na tax rate bago pa man maisabatas ang SB 2272.

"Bawat oras na hindi nalilina ang regulasyon ito, may mga empleyado, guro, at estudyante na matinding maapektuhan. Umaksyon na ang BIR bago pa matuluyang magsara ang mga paaralan. Ang mga paaralan ay mga gateway sa isang mas magandang buhay at kung hindi natin maprotektahan ang mga ito, hindi natin mabibigay ang pangako ng mas magandang kinabukasan para sa maraming mga Pilipino," pagtatapos ni Hontiveros. #####

S a m a n t a l a , mapapabilang naman sa “mas pinaigting na restrictions” ang probinisya ng Laguna at Cavite na posibleng malimitahan ang entertainment at recreational venues, amusement parks, traditional cockfights, contact at indoor sports, gayundin ang indoor tourist attractions.

Malilimitahan hanggang sa 30 porsyento ang mga kapasidad sa mga salon, parlor at beauty clinics sa Laguna at Cavite, habang ang mga indoor dining naman ay limitado hanggang sa 20 porsyento na lamang at maaari pa ring maitaas hanggang sa 30 porsyentong kapasidad kung mayroong naigawad na safety seal certification ang isang establisyimento.



1,416 OF BLOOD BAGS COLLECTED IN CALABARZON DURING THIS YEAR'S BLOOD DONATION DRIVE

This year's blood donation drive conducted in CALABARZON (Cavite, Laguna, Batangas, Rizal, Quezon) by the Regional Voluntary Blood Services Program (RVBSP) in coordination with various partner agencies including the Alagang Kapatid Foundation, Iglesia ni Cristo and local government units of various provinces yielded a total of 1,415 blood bags and 9 platelet apheresis during the celebration of World Blood Donor Day from June 11-25, 2021.

A total of 225 successful blood donors donated their blood during the blood donation drive in the town of Mendez in the province of Cavite; 108 in Los Banos, Laguna; 81 in Tanay, Rizal; 189 in Camp Karingal, Quezon; 167 in Malvar, Batangas; 227 in General Trias, Cavite; 135 in Gumaca, Quezon; 209 in Calamba City, Laguna; and 73 successful blood donors contributed during the blood donation activity conducted at Hotel Sogo Cubao in Quezon City.

In support of the Department of Health's (DOH) mandate to provide adequate supply of safe and non-remunerated blood supply for patients needing blood products, the Regional Voluntary Blood Services Program regularly conducts blood and apheresis donation among its employees.

RVSP Coordinator Myla Velgado said that the routine conduct of blood donation helps ensure a sufficient and quality supply of blood products. “A bag of blood can save up to three lives. It is

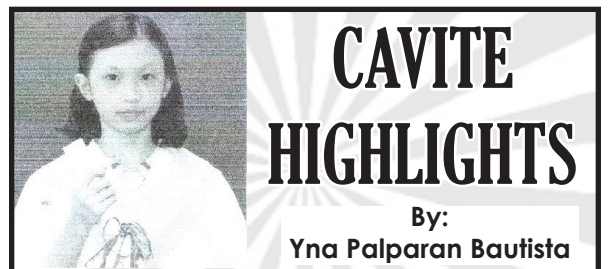
separated into platelets, plasma, red blood cells and white blood cells which can be given to at least three patients.”

“Blood is free. Blood should be shared. Blood donation is the most humane gesture a person can do. And it is the simplest way to save a life,” Velgado stated.

According to

the World Health Organization, blood donation by 1% of the population is the minimum needed to meet a country's most basic requirements for blood.

“Let us continue saving lives by voluntarily donating our blood. It is the foundation of safe and sufficient blood supply,” Velgado emphasized.



Gen. Mariano Alvarez was 65 years old when the Phil. Revolution started. He was the incumbent Capitan Municipal of Noveleta at the time. He felt bad for the many abuses of the Spaniards so he joined the Katipunan in April 1895. It earned him the Presidency of the Magdiwang Council in Cavite. He relinquished the Presidency to Gat. Andres Bonifacio and took the title Pangalawang Haring Bayan. When Andres Bonifacio was executed, Mariano was so shocked that he withdrew from the Revolutionary Movement. He died on August 25, 1924.
