PH SEEN ACHIEVING HERD IMMUNITY IN MID-2022

The Philippines would be among the last countries in the region, together with Vietnam and Taiwan, to vaccinate 70 percent of its population and achieve the so-called herd immunity, UK-based think tank Oxford Economics said on Tuesday.

Vaccinated people are protected from getting the disease and passing on the virus, thus inoculating such a big

number would break the chain of transmission and stop the further spread of COVID-19.

Oxford Economics projected that it would take up to the middle of next year for the Philippines to inoculate some 78 million people or 70 percent of its population of 111 million.

Across Asia, low vaccination rates, combined with low tolerance to the virus

in several places, kept many Asian economies vulnerable to COVID-19 setbacks, Oxford Economics head of Asia

economics Louis Kuijs and senior economist Lloyd Chan said in their report titled "Limited vaccination holds back recoveries."

Achieving herd immunity is necessary to allow the reopening of more economic activities. The longer it takes to

achieve this, the longer the delay in economic recovery.

Oxford Economics said it expected Singapore to reach that threshold in August; China in less than five months from now; Japan, Malaysia, New Zealand and South Korea, in a little over five months; Australia, Hong Kong and Thailand, in less than 10 months, and India and Indonesia, in a little over 10 months.

As of July 10, Taiwan and Vietnam had the slowest pace of mass vaccination, while the Philippines ranked third to the last among Asia-Pacific countries in the percentage of the population getting vaccinated.

The government is hoping to fully vaccinate some seven million individuals by the end of the month, according to National Task Force

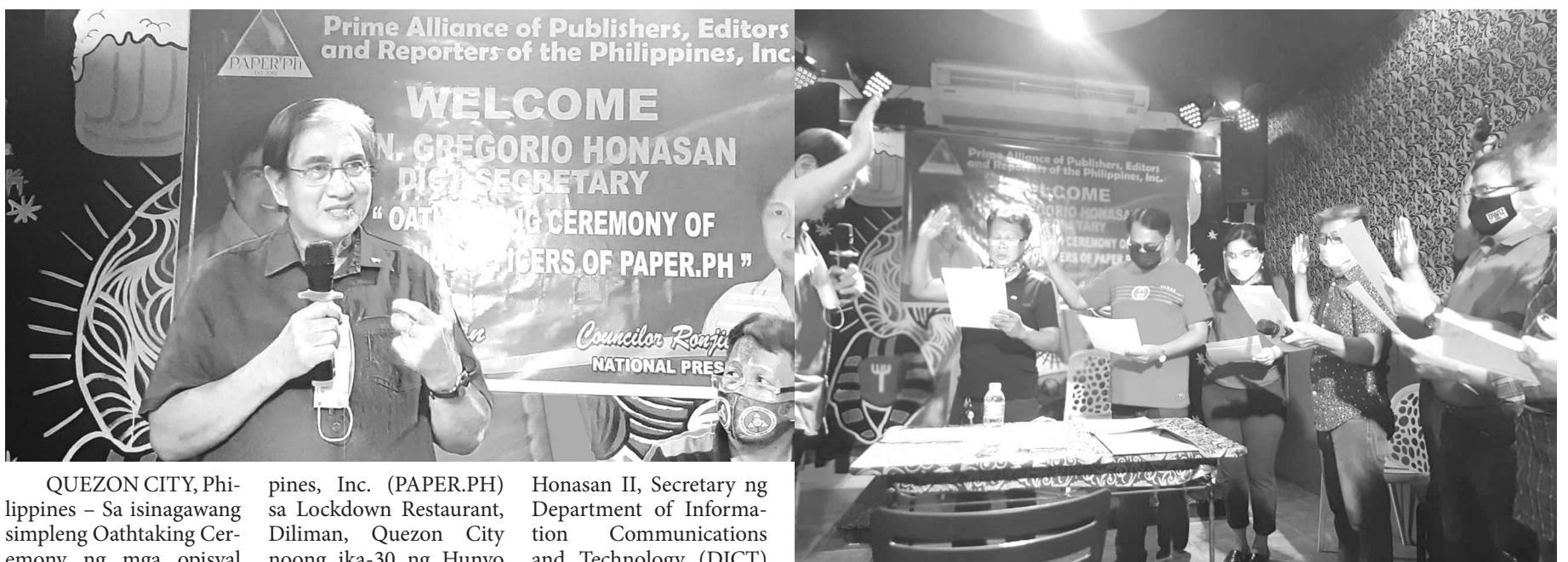
Against COVID-19 chief implementer Secretary Carlito Galvez Jr.

This would be equivalent to only 6.3 percent of the country's population.

So far, some 3.5 million individuals are considered fully vaccinated after receiving two doses since the government rolled out its mass immunization drive in March.

Calamba City, Laguna - To continue the protection of the remaining forest lands in the region, the Department of Environment and Natural Resources (DENR) CALABARZON has officially entered into several Memorandum of Agreement (MOA) with various Local Government Units (LGUs) in the region to formally formulate, adopt, and implement the Forest Land Use Plan (FLUP) for their respective municipalities.

Forest Land Use Planning, as defined in the Forest Management Bureau Technical Bulletin 2, "is a participatory process of allocating forests and forest lands (FFL) as natural resource asset by the government under

appropriate management, tenure arrangement and eventually putting these assets according to their best uses to harmonize uses of FL and to attain a balance of production activities with forest protection and biodiversity conservation."

FLUP ensures a sustainable allocation and management of FFL that will provide environmental, social, and economic benefits to the public. FLUP also aims to identify open access areas and determine the best management and use for these open areas.

FLUPs are formulated by LGUs with technical assistance provided by Field and Regional Offices. LGUs are given opportunities to formulate their FLUPs

upon submission of their Letter of Intent (LOI). Moreover, municipalities with remaining open access areas within their forestlands are targeted for FLUP formulation.

In the CALABARZON Region, FLUP started in 2011 where a total of forty-seven (47) plans have been formulated from 2011 to 2020. For CY 2021, there are nine (9) targets for FLUP preparation/formulation and six (6) targets for FLUP adoption. This 2021, Lobo, Batangas has started to implement their FLUP.

According to DENR CALABARZON Regional Executive Director Nilo B. Tamoria, FLUP shall be done "beyond compliance". It is coordination between

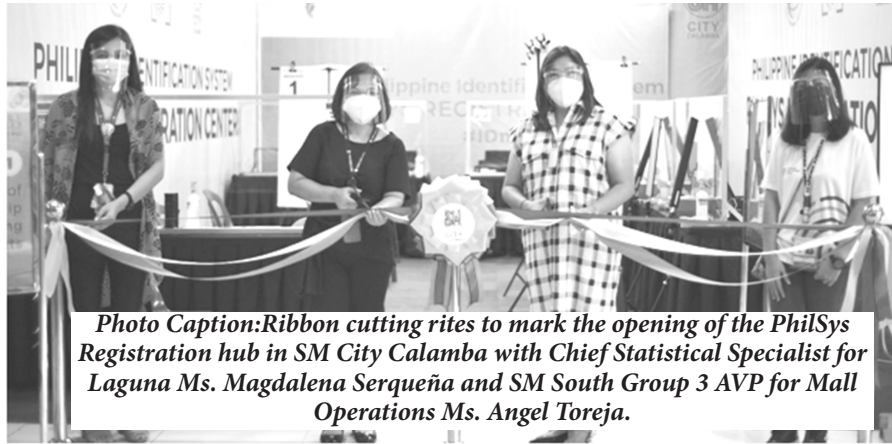

PhilHealth releases guidelines for COVID-19 vaccine injury and death compensation

The Philippine Health Insurance Corporation (PhilHealth) recently announced its compensation package for those who will develop serious adverse effects (SAEs) following inoculation for COVID-19 that will lead to hospitalization, permanent disability or death. The said package and its guidelines are contained in its PhilHealth Circular No. 2021-0007 published on June 18, 2021.

In a recent media forum of the Department of Health, the state health insurer said that the compensation package is only available to those who received COVID-19 jabs through the Philippine COVID-19 Vaccination Program. The package is capped at P100,000 for hospitalizations to cover remaining charges after deduction of PhilHealth benefits, mandatory discounts, and other coverage provided by private health insurance companies and health management organizations (HMOs).

Similarly, a lump sum of P100,000 per beneficiary in case of permanent disability or death.

However, PhilHealth clarified that it will cover patients who received inoculations through other initiatives, especially in the private sector, if the vaccines were sourced from the country's Philippine COVID-19 Vaccination Program.

The compensation covers claims filed from March 3, 2021 to March 2, 2026 or until completion of the vaccination program, whichever comes first. Those who will avail of

this package must have had at least one vaccine received through the said Vaccination Program.

In addition, it must also be established that the vaccine does not have a Certificate of Product Registration at the time of inoculation; the beneficiary has not received compensation from COVAX no-fault compensation program; and the result of the **causality assessment must be "vaccine product-related reaction" or vaccine quality defect-related reaction**.

Hospitalization benefits can be availed of more than once if the cap of P100,000 has not been reached yet. However, coverage for permanent disability or death can only be claimed once.

Among the requirements for compensation claims for hospitalization are proof of COVID-19 vaccination (vaccine card or slip); vaccine injury assessment survey; statement of account; medical certificate; and official receipt indicating deductions of PhilHealth benefits, private insurers/HMOs, and out-of-pocket expenses. Other supporting documents such as duly signed physical examination report describing the disabling manifestation or death certificate should also be included for permanent disability and death claims, respectively.

DOH-CALABARZON DISTRIBUTES ART THERAPY KITS TO CHILDREN IN EVACUATION CENTERS

With the growing number of evacuees in various towns affected by the continuing eruptions of Taal Volcano, the Department of Health (DOH) - CALABARZON (Cavite, Laguna, Batangas, Rizal, Quezon) started distributing art therapy kits to children in evacuation centers providing a therapeutic outlet for young people experiencing instability due to calamity and the present pandemic.

Ms. Paulina A. Calo, Regional Mental Health Outcome Coordinator who led the distribution activity stated that children also feel anxiety brought by the taal eruption and the ongoing pandemic. "With their usual routine disrupted by the closing of schools and the increased worries and concerns from their families around them, they can be considerably upset and distressed."

"We have to ensure that kids also have ways to cope with the emotions that come during this new normal. And by exploring their creativity through

art we can provide them a way to express their feelings."

Calo said they aim to deliver at least 500 art therapy kits to various evacuation centers in the towns of Agoncillo, Balayan and Balete in Batangas.

An art therapy kit includes a sketch pad, pencil, sharpener, eraser, crayons, watercolors and coloring books.

Art therapy is a type of therapy that uses art and artistic mediums to help people explore thoughts and emotions in unique and visually expressive ways.

"Recipients of the art therapy kits were grateful kits as they now have a creative outlet to process their emotions and channel their energy during their stay in evacuation centers."

"Art activities like drawing provides is an activity that promotes calmness and peace of mind because it focusses one's attention into something comforting," Calo concluded. (GLEN RAMOS)

Galvez said the government was confident of reaching the seven million target this month because it was set to receive a shipment of 3.2 million doses of Johnson & Johnson's Janssen vaccines.

Requiring only a single jab, administering the entire Janssen shipment would be equivalent to 3.2 million fully vaccinated people.

Senior citizens and persons with comorbidities would be the priority in the distribution of the single-dose vaccine and each region would be given at least 100,000 doses each, according to Health Undersecretary Myrna Cabotaje.

On Tuesday, however, OCTA Research called on the government to continue to make the National Capital Region (NCR) and eight other areas the priority in its vaccination drive to help the country get through the pandemic faster.

These are Pampanga, Bulacan, Batangas, Cavite, Laguna, Rizal, Metro Cebu and Metro Davao, areas with the most number of COVID-19 cases outside NCR.

"The key to success is to stick to a plan. We have a blueprint, NCR Plus 8. We hope the plan would not be tainted by politics and different influences. If we stick to that plan, the country will move forward," OCTA's Ranjit Rye said at the Laging Handa briefing.

This also has to be

done urgently given the threat posed by the more contagious Delta variant of the virus, he added.

Meantime, the Department of Health and the World Health Organization (WHO) have signed an agreement on the conduct of clinical trials on COVID-19 vaccines to find the most suitable brand for Filipinos, according to the Department of Science and Technology.

Health Secretary Francisco Duque III and WHO chief scientist Soumya Swaminathan signed the agreement, Undersecretary Rowena Guevara of the DOST said on Tuesday.

Guevara said that the trials were meant to also find out the most effective vaccine that would provide adequate protection and be easy to administer and manufacture in the country.

The trial would involve four vaccines, but Guevara said she could not name these without approval from the Food and Drug Administration.

The WHO has also provided the final clinical trial protocol, the standard operating procedures and the investigational brochures for the vaccines, she said.

The Philippines has so far been using Sinovac, AstraZeneca, Sputnik V, Pfizer and Moderna vaccines in its immunization drive. It is also set to get Johnson & Johnson vaccines later this month.

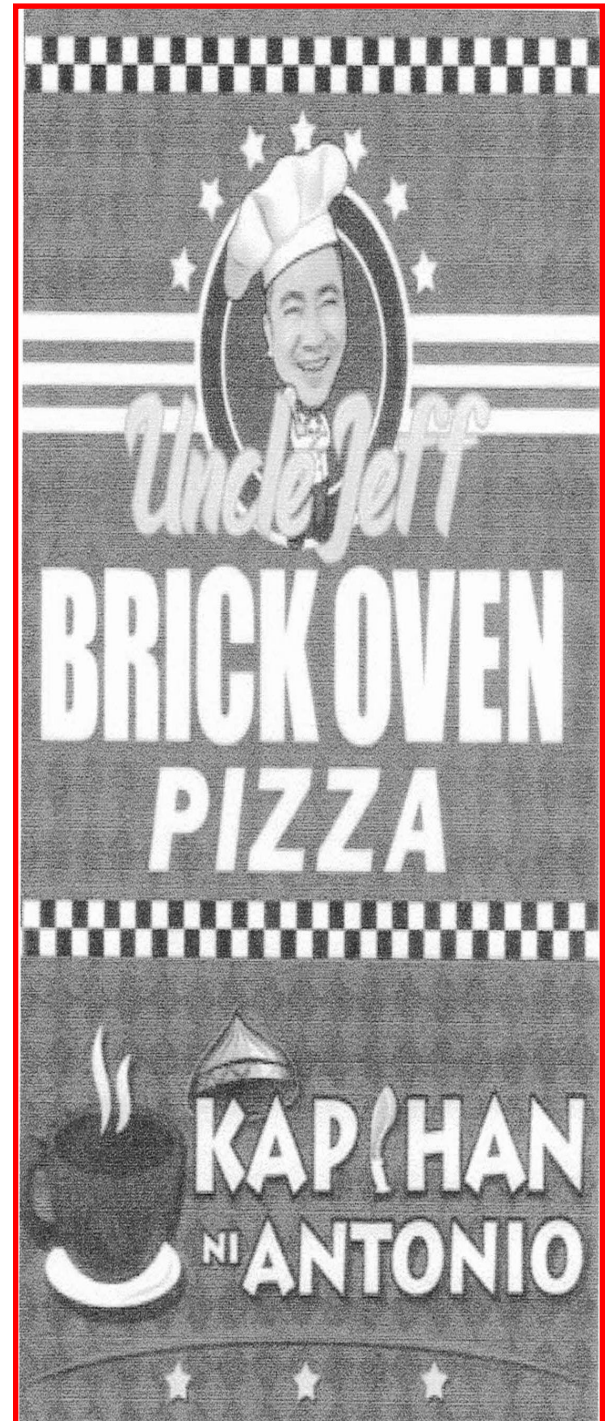
