Ayon kay Philippine Genome Center Executive Director Cynthia Saloma,

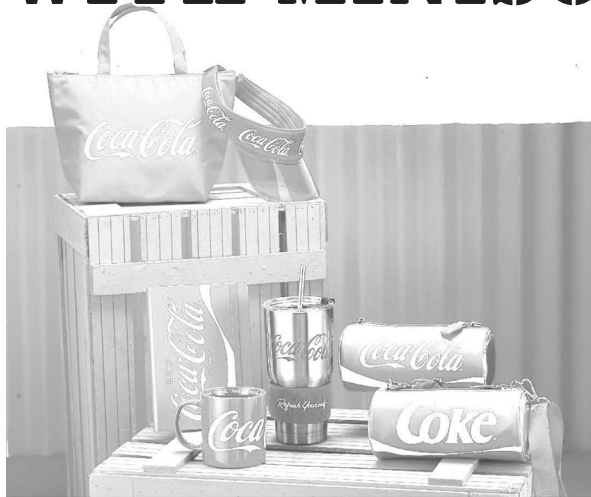
ang Lambda variant ay walang kinalaman sa pagtaas ng kaso ng Covid-19 sa bansa.

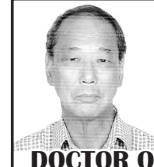

sa Metro Manila na itinuturing na epicenter ng pandemiya.

Mula sa total na populasyon na 16.2-milyon, 4.44-milyong doses ng COVID-19 vaccines pa lamang ang naibibigay habang nasa 12-milyong doses naman ang bakunang natanggap ng Maynila.

"Sabihin na natin na ang epicenter ng pandemya ay talaga namang ang Metro Manila o NCR. Ngunit dahil kalapit ng NCR ang Cavite at Laguna, hindi maiwasang kumalat din sa ating lalawigan ang malalang epekto ng COVID-19. Karamihan sa ating mga residente ay naghahanapbuhay o malimit na napapadpad sa

NCR," ayon kay Remulla.

"Kaya't hiling po sana natin sa Department of Health (Philippines) and on behalf of the Region 4-A LGUs, ay kung maaari bigyan naman po ng pansin ang kakulangan ng supply ng bakuna sa ating rehiyon," dagdag ng Gobernador.

Tanging ang DOH lamang ang responsable sa nasabing usaping kakulangan ng suplay sa bakuna dahil hindi naman raw umano direktang nakakausap ng mga LGUs ang manufacturers ng mga bakuna.

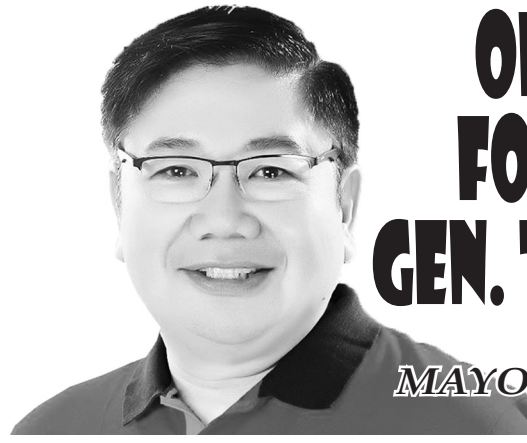
"As of August 6, our supplier (American biotechnology company Novavax) has applied for emergency use authorization of its COVID-19 vaccine in

the Philippines. The FDA has yet to approve the application. Ang Novovax lamang ang siyang pinayagan ng DOH para makipag-nego at mag-supply sa mga LGU habang ang mga brands na AstraZeneca, Pfizer-BioNTech and Moderna ay tanging DOH lamang ang maaaring makipag-usap, meaning they do not entertain inquiries from us at the LGU level," pagbabahagi ni Remulla.

Aniya, hindi pa talaga sapat ang bakuna upang tuluyang masugpo ang nakakahawang sakit na COVID-19.

"The fact remains we simply do not have enough vaccine support to fight this global pandemic," ayon kay Remulla.

health at a time when it is most needed," Poe said in her resolution.

"Instead of being utilized to support and boost the country's pandemic response, the funds either remained idle or were not properly and immediately used for their purpose," she stressed.

A COA report attributed the deficiencies to the DOH's non-compliance with pertinent laws and regulations, including use of funds not for intended purpose, low or zero utilization, improper charging of transactions, doubtful liquidations, procurement without legal basis, and

procedural flaws, among others.

"These deficiencies contributed to the challenges encountered and missed opportunities by the DOH during the time of state of calamity/national emergency, and cast doubt on the regularity of related transactions," COA said in its report.

Poe said that these deficiencies prove to be "counter-beneficial" to the government's efforts to curb the spread of the disease at a crucial time.

"Instead of being utilized to support and boost the country's pandemic response, the

funds remained idle or were not properly and immediately used where they should go," she said.

"Inefficiencies in the midst of a health crisis make our people bear the brunt," she stressed.

Ahead of the upcoming 2022 budget deliberation, Poe pointed out that there are moves to increase the DOH fund for COVID-19 response and recovery.

"The DOH has a lot of explaining to do. We expect the Senate investigation will help correct these deficiencies, seek accountability and ensure future funds are better managed," Poe said.

## PhilHealth assures coverage of patients admitted in ERs, tents

Patients admitted in emergency rooms (ERs) and tents within the hospital compound pending availability of hospital rooms are covered by the Philippine Health Insurance Corporation (PhilHealth).

This was reiterated by the state health insurer as COVID-19 cases continue to surge and several health care facilities have reportedly been running at full capacity to accommodate patients.

In its Advisory Nos. 2021-027 and 2021-028, PhilHealth stressed the provision of PhilHealth Circular No. 35, s-2013 that when admitted patients must stay in ER or within the hospital premises pending availability of rooms, full payment shall be given, provided the patient stayed in the hospital for 24 hours or more.

The Department of Health through Memorandum No. 2020-0171 has instructed hospitals to adopt strategies to increase their capacities to manage COVID-19 during surge of cases that includes setting up tents when necessary.

PhilHealth beneficiaries admitted in tents within the compound of accredited hospitals in areas categorized as high or critical risk for COVID-19 shall be compensable starting March 29, 2021.

The state agency also asserted that patients including COVID-19 cases being admitted and managed in ER due to lack of available regular rooms shall be paid by PhilHealth if the patient stayed within the hospital for at least 24 hours. However, private hospitals are required to submit a justification letter together with their claim in compliance with the said policy.

On the other hand, patients confirmed with COVID-19 and developed into severe illnesses can avail themselves of inpatient benefits for mild pneumonia, P43,997; moderate pneumonia, P143,267; severe pneumonia, P333,519; and critical pneumonia for P786,384. An intermediate package for previously managed as probable COVID-19 case but had negative RT-PCR test results are also covered with the Intermediate package amounting to P18,000 and P38,000 for moderate and severe/critical pneumonia, respectively.

Meanwhile, PhilHealth calls on health care providers to honor all availments including those of patients staying in tents, ERs or within the hospital premises wherein services are provided as part of the inpatient care. ###

tahungan operations in Cavite, that include updating of the master list of fish cages, fish traps, and tahungan operators; issuance of notice to self-demolish for non-permittees; demolition of the remaining illegal fish cages, fish traps, and tahungan operations for non-permittees who failed to self-demolish their structures; requiring tahungan operators with permits to shift to long-line method of shellfish propagation as prescribed by the Bureau of Fisheries and Aquatic Resources; and declaration of temporary suspension of the issuance of permits for the transport of bamboos to Cavite for aquaculture purposes.

Per available data from the concerned local government units (LGU), Bacoor City has 351 tahungan operators with permits on-hold per Mayor's order as the said operators failed to pay annual registration fee due to the issue on the proposed Bacoor reclamation projects. On the other hand, no permit was issued to the 23 pond-type operators in Kawit, Cavite and 26 bamboo fish traps in Cavite City. In the same way, no permit or fishing license was issued to any fish pen tahungan, and sapra operators in Noveleta, Cavite as certified by the Municipal Agriculturist.

Considering the urgency of the directive of the Secretary, DENR Legal Affairs Service Director, Atty. Norlito A. Eneran said the demolition of the structures which totally have no corresponding permits should be prioritized.

However, the economic effect of the said action to the affected fisherfolk should be taken into consideration, he emphasized.

In response to the request of the DENR CALABARZON for advice and assistance regarding the plan presented, the KRA 5, led by Department of Justice Assistant Secretary Margaret V. Castillo-Padilla, advised the regional department to coordinate with the Department of Social Welfare Development and Bureau of Fisheries and Aquatic Resources with regard to the assistance which may be provided to the affected fisherfolk, and with the concerned LGUs and the Department of the Interior and Local Government (DILG) regarding the dismantling operations.

Gorospe said they will officially request DILG Secretary Eduardo Ano to direct the concerned LGUs to demolish those structures without permit and to provide security during the demolition. A special KRA 5 meeting will be held on August 17, 2021 for DENR CALABARZON to present its concrete plan and timeline for demolition. The

said meeting shall also be attended by the concerned LGUs.

Manila Bay Site Coordinating and Management Office-4 Deputy Site Coordinator, Cynthia N. Rozaldo said they should be able to address the issues on the fish cages, fish traps, and tahungan operations in Cavite by August 30, 2021 as per directive of the Secretary.

Early in July 2021, Environment Secretary Roy A. Cimatu ordered DENR CALABARZON Regional Executive Director Nilo B. Tamoria to conduct an immediate and complete inventory of all fish pens, fish cages, baklads, and sapras in Cavite, and to identify those with permits to operate. Cimatu said “legitimate operators will be required to repair their damaged fish pens and cages while those without permits shall be ordered to immediately self-demolish”. The said instruction was in view of the huge amount of bamboo poles from fish pens, fish cages, and baklads/sapras, which were washed from Cavite waters into the shore of Manila Bay due to the recent southwest monsoon.###

# DOH-CALABARZON INITIATES 'PROJECT DELTA' TO STOP LOCAL TRANSMISSION

The Department of Health (DOH) CALABARZON (Cavite, Laguna, Batangas, Rizal, Quezon) recently initiated "Project DELTA" (Detect Early Local Transmission through Antigen Testing) to provinces where the Delta variant were identified.

The Regional Epidemiology and Surveillance Unit (RESU) together with the Regional Infectious

Disease Cluster led the mass swab testing in the Province of Laguna from July 30, 2021 to August 13, 2021, particularly in Brgy. Sta. Monica in San Pablo City, Brgy. San Nicolas in the town of Bay, Brgy. Wawa in Lumban, Brgys. Barandal and Canlubang in Calamba City. A total of 343 individuals were tested.

Regional Director Eduardo C. Janairo stated that those who

have undergone antigen testing were direct contacts of individuals who were afflicted with the Delta variant virus. "We need to strengthen the implementation of the prevent, detect, isolate, treat and re-integrate response strategies against the Covid-19 virus."

"Ang mga health workers natin kasama ang ating mga LGUs ay tuloy-tuloy ang ginagawang mass testing sa mga barangay na mayroong mga identified delta variant cases. Kailangang sa community pa lang ay malaman na natin kung sino ang mayroon nito upang ma-isolate na agad at mabigyan ng agarang gamot upang hindi na kumalat at makahawa pa ng iba."

"Mabilis na kumakalat ngayon sa ating bansa ang mga COVID-19 variants kaya't kailangang nating doblehin ang pag-iingat upang tayo ay maging ligtas. We must strictly

follow community safety protocols. Magpabakuna na kung hindi pa nakatanggap ng Covid vaccine upang proteksyon," Janairo reminded.

According to the Regional Biosurveillance

Update of August 13, 2021, there were a total of 111 Delta variant cases identified from among the five provinces namely Cavite (41 cases), Laguna (35 cases), Batangas (14 cases), Rizal (14 cases) and Quezon (7).

Janairo added that

there are no active cases recorded. There are however 48 recoveries, 34 cases for verification, 27 were pending retest result and 2 deaths reported.

The Project "Delta" Initiative started last July 22, 2021.
