PGC's Botika on Wheels goes to Dasmariñas



Continuing the delivery of basic health care services amidst the pandemic, the Office of the Governor – Extension went to Paliparan I, Dasmariñas City, Cavite on June 17, 2022 for the door-to-door distribution of free medical supplies including essential medicines, maintenance medicines, vitamins and insect repellent through the Botika on Wheels program benefitting adults, senior citizens and children.

The Botika on Wheels team was accompanied by barangay health workers and the police in going around the community to deliver the basic medical supplies to the recipients. Some 1199 senior citizens and 1395

children in Paliparan, Crossing, Tabing Ilog, Carissa Homes Subdivision, Camit Compound, Square Subdivision, Picache Compound, Tiera Bonita, Beberino Compound, Dimaranan Compound, Terra Alta Homes, Nia Road, Nasta Jie, Vina Compound, Sarita, DRV, Kanluran, Martinez and Tondo benefitted in the aforementioned program.

The Botika on Wheels program was launched in June 2020 as a response to the basic medical needs and health care services of Caviteños during community quarantine period when the citizens were not allowed to leave their home and residences. (PICAD)

PH terminated oil exploration talks with China: Locsin

MANILA – The Philippines was the one that initiated the termination of oil exploration talks with China, Foreign Affairs Secretary Teodoro Locsin Jr. revealed



Thursday.

In his speech during the Department of Foreign Affairs' (DFA) Foundation Day, Locsin said both sides tried to negotiate for three years and got as far as constitutionally possible.

However, another step forward would have risked a "constitutional crisis".

"That explains the sudden pull-back on my part which unraveled three years of sincere hard work on the part of Wang Yi and me. We had both tried to go as far as we could -- without renouncing China's aspiration on his part; and constitutional limitations on my part. I shut down shop completely," he said.

"The president

had spoken. I carried out his instructions to the letter: oil and gas discussions are terminated completely. Nothing is pending; everything is over," he added.

He noted that throughout the three-year talks, the Philippines never surrendered even a particle of its sovereignty.

The top diplomat said it now falls on the next administration's shoulders to protect the Philippine sovereignty "all the way to the wire".

"The irreducible template of what is constitutionally possible is there in black and white. Surrender of any portion of Philippine sovereignty is not an option," he said. (PNA)

Ang PhilHealth Konsulta o Konsultasyong Sulit at Tama ang benepisyong magbibigay ng primary care sa mga miyembro at magbibigay daan sa mandato ng UHC Law na bigyan ang lahat ng Filipino ng primary health care.

Si Cristina Villente ng Sinilong Laguna ay isa sa maraming miyembrong nakagamit na ng PhilHealth KonSulTa. Nagparehistro siya sa kanyang napiling Konsulta provider at libreng nakagamit ng benepisyong pangkalusugan pati ang kanyang mga anak.

Ayon sa kanya, malaking bagay ang PhilHealth Konsulta dahil mababantayan ang kalusugan ng bawat miyembro. "Ako ay isang 4Ps at PhilHealth member. Nagamit ko po ang aking PhilHealth, pati sa aking mga anak, lalo na kapag walang pera. Kapag member ka

ng PhilHealth talagang ini-entertain ka nila. Nito lang 2022 nagpa-update ako ng MDR, nabanggit ng staff na meron nang PhilHealth Konsulta. Kaya agad akong nagpalista sa aking napiling Konsulta provider at nagpa-konsulta po agad ako. Ako po kasi ay merong maintenance na. Maganda po ang sebisyo ng KonSulTa, ang mga duktor ay masusing inaalam kung ano ang mga nararamdaman, kukunin ang vital signs mo at kung kailangang magpa-laboratory, bibigyan ka nila ng request for laboratory. At binigyan din po ako ng libreng gamot. Maganda at personal kang titignan ng doctor. Ipapaliwag mismo ng duktor kung bakit ito ang nararamdaman mo. Napaka-importante po ng may PhilHealth, napaka-laking tulong po sa bata lalo na sa matanda. Maganda po ang KonSulTa, malaking tulong".

Sa PhilHealth Konsulta, lahat ng miyembro ay kwalipikado sa benepisyong ito kailangan lamang na naka-rehistro sa isang PhilHealth accredited

Konsulta facility na pinili ng miyembro. Ang pagpaparehistro ay maaaring gawin online, sa bahay (self-registration) o magtungo sa pinakamalapit na PhilHealth Local Health Insurance Office o ibang ahensya na binigyan ng permiso ng PhilHealth na magsagawa ng assisted registration.

Sakop ng PhilHealth KonSulTa ang serbisyong medikal gaya ng initial at follow up konsultasyon sa duktor o regular na pagpapatingin at pagsusuri, health screening at assessment; piling laboratory o diagnostic services, at piling mga gamot batay sa reseta ng duktor. Para sa kumpletong listahan ng mga serbisyo at benepisyong maaaring magamit sa ilalim ng PhilHealth Konsulta sa www.philhealth.gov.ph.

Para sa mga hindi pa rehistrado, kinakailangan lamang na magpatala at magsumite ng PhilHealth Member Registration Form (PMRF) sa pinakamalapit na tanggapan ng PhilHealth upang mabigyan ng PhilHealth Identification Number (PIN).###(VVA)

Upang maiwasan ang gastos sa gasolina at pamasaha, hinimok ng ilang senador ang mga ahensya ng gobyerno at mga pribadong kompanya sa bansa na ipagpatuloy ang work-from-home o iba pang flexible work arrangements.

Kaugnay nito, ipinanawagan ni Sen. Sherwin Gatchalian at Sen. Grace Poe ang agarang implementasyon ng Republic Act No. 11165 o Telecommuting Act kung saan nakasaad na maaaring magtrabaho sa bahay ang isang empleyado sa pamamagitan ng 'computer technology' o anumang kondisyon at tuntunin ang n a p a g k a s u n d u a n

sa pagitan ng isang empleyado at kumpanya.

"Our office may look empty for some but we're practicing work from home arrangement to save on gas, avoid traffic congestion, save time and eliminate daily commutes," ani Gatchalian.

"This is the new normal and working remotely can prove to be as productive as those working in an office setting. This (WFH) is a huge relief, especially now that fuel prices are nearly P100 per liter," pagpapatuloy ng senador.

Upang mas mapalawig pa ang flexible work arrangement, hiniling din ni Gatchalian na maisabatas na ang

kaniyang panukalang magbibigay ng tax incentives sa mga empleyadong nasa WFH arrangement at income deduction naman para sa mga employer.

Sa ilalim ng Sentae Bill No. 1706, mababawasan ng P25.00 ang binuwisang kita ng isang empleyado sa bawat oras ng trabahong kaniyang ginawa habang naka-WFH.

Iginiit din ng senador na alisin na ang pagpataw ng mga buwis sa mga allowance at iba pang benepisyong empleyado na nakalaan para sa 'telecommuting expenses' na hindi hihigit sa P2,000 kada buwan.

Lawmaker joins DOH, health groups call to veto vape bill

MANILA – Senator Pia Cayetano and health advocates on Thursday called on President Rodrigo Roa Duterte to veto, before stepping down, the Senate Bill (SB) 2239 or the Vape Regulation Bill.

Cayetano said the recent Supreme Court (SC) ruling she hailed, which recognized the continued regulatory authority of the Department of Health

(DOH) and the Food and Drugs Administration (FDA) over cigarettes and other tobacco products, is also saying that anything that affects the health should be regulated by FDA.

"This, to me, would clearly include vapes and e-cigarettes," she said in a media briefing at the Senate in Pasay City.

SB 2239 was filed on May 26, 2021 by Senators

New bureaus under DOLE eyed to assist job seekers



MANILA – Returning Senator Jinggoy Estrada on Wednesday said he plans to file bills creating two bureaus under the Department of Labor and Employment (DOLE) to help address unemployment.

He said his proposed National Employment Assistance Center and National Manpower, Data, and Placement Service are like the Public Employment Service Office (PESO) where database of job seekers will be stored to provide them with additional assistance.

"Yung (The) National Power Data Center parang yung (like the) PESO bill. Maglalagay tayo ng

isang (We will put an) agency under the Department of Labor na lahat ng data na kailangan ng mga nangangailangan ng trabaho magre-register dun (that all the data needed by job seekers will register there)," Estrada said in an interview with CNN Philippines.

Estrada, one of the 12 senators elected in the last May 9 polls, said the incoming Senate majority bloc vowed to elect him as chairperson of the Senate committee on labor, employment and human resources development in the 19th Congress.

Once chosen to head the Senate panel, he promised

Control Alliance Philippines (FCAP) Executive Director Dr. Maricar Limpin said it should be the FDA and not the Department of Trade and Industry (DTI) as provided in the bill, that will regulate e-cigarettes and vapes.

"Definitely, DTI cannot do the job of protecting the health of the country. It is only the FDA who has the power to

do that with the leadership of the Department of Health," Limpin said during the media briefing.

Also joining Cayetano and Limpin's call are Southeast Asia Tobacco Control Alliance (SEATCA) Executive Director and Philippine Medical Association (PMA) member Dr. Ulysses Dorotheo, former FDA Director-General Dr. Kenneth Hartigan-

Go, Philippine Pediatric Society (PPS) Tobacco Control Advocacy Group chairperson Dr. Rizalina Gonzales, and Health Justice Philippines legal consultant lawyer Benedict Nisperos.

Early this month, DOH Secretary Francisco Duque III expressed his concern with the Vape Bill saying it should not be enacted into law.

"We will just have

to wait what happens next, but I doubt that the President will even sign that bill," Duque said at the Kapihan sa Manila Bay forum.

He assured that he is in constant communication with the Office of the President and he remains hopeful that the proposed measure will not be signed by Duterte into law. (PNA)

Southbound Lane of EDSA-Kamuning Flyover to Stay Closed for A Month-Long Repair



The Department of Public Works and Highways announces the extension to one-month closure of the southbound lane of EDSA-Kamuning Flyover in Quezon City for rehabilitation works

starting Saturday, June 25, 2022.

Citing a report to DPWH National Capital Regional Director Nomer Abel P. Canlas, Quezon City 2nd District Engineer Eduardo V. Santos said

that the repairs spanning 30 meters, girder to girder and pier to pier, will cover a portion of deck slab of 2nd lane at southbound direction.

"We need at least 30 days to complete the major

repair of the busy flyover as manual labor will be done. Also, concrete curing will be carried out for seven days," said District Engineer Santos.

Portion of the southbound flyover was

already closed to traffic last week for immediate repairs after a recent inspection showed sightings of large cracks and potholes.

"We are sorry for the inconvenience but

the public's safety is our priority here," said Director Canlas.

Motorists are advised to take possible alternate routes such as the service road while the repair is ongoing.

Estrada said he also will support any measure that will amend the economic provisions of the Constitution to allow 100 percent foreign

ownership in the country.

"We can generate more jobs kapag pwede na ang (if we allow the) 100 percent foreign ownership. We have to amend the Constitution with regards only to the economic provision," he said.

Estrada also believes that the agriculture and tourism sectors should

be strengthened to generate more jobs and provide more incentives to the farmers.

He said he fully supports the decision of President-elect Ferdinand "Bongbong" Marcos Jr. to lead the Department of Agriculture (DA) "at least for now" amid the looming food shortage due to Russia's war on Ukraine and global oil prices hikes.

"I admire the decision of incoming

President Bongbong Marcos that he will lead the agriculture sector to focus on the problems of Department of Agriculture," he said.

An April 2022 Labor Force Survey conducted by the Philippine Statistics Authority (PSA) shows that around 2.76 million Filipinos remain jobless.

PSA is expecting the unemployment rate to continue decreasing as Covid-19 alert

levels relax amid an increasing Labor Force Participation Rate (LFPR).

"Nagfala-fluctuate siya. Ang pinakamababa niya actually was in October 2019 na nasa 4.5 percent. Hindi naman talaga significant pero nakikita naman natin tumataas (yung ating LFPR (Labor Force Participation Rate). Dumadami ang mga gustong mag-participate sa ating

labor market (The pre-pandemic was at the 5 percent level. It fluctuates. The lowest [unemployment rate] was in October 2019 at 4.5 percent. It is not really significant but we see our LFPR increasing. More are interested in participating in our labor market)," National Statistician and Civil Registrar General, Undersecretary Dennis Mapa said in a recent media briefing. (PNA)
