



## PSA encourages parents to register kids for national ID

MANILA – Getting a national ID could eventually ensure a smoother enrollment process for children aged 5 and up, the Philippine Statistics

Authority (PSA) said Sunday.

Emily Pagador, officer-in-charge and assistant national statistician of the PSA's Use Case Development

and Management Service (UCDMS), said this is one of the many benefits of getting children to register in the Philippine Identification System

(PhilSys).

Currently, children aged 5 and up can register for a national ID in PSA registration hubs. However, they have to update their biometric information by the age of 14.

## Two new technology adaptors from Cavite attend Technology Training on the Production of Enhanced Nutribun Squash Variant



DOST-Cavite-assisted firms SIR EZER Bakery and Maestra Panaderia underwent a Technology Training on the Production of Enhanced Nutribun Squash Variant last 15-17 August 2022. Both firms previously signed a Technology Licensing Agreement to adopt the Enhanced Nutribun Squash Variant (ENSV) technology of the DOST-Food and Nutrition Research Institute (DOST-FNRI).

With the aim to improve the nutritional status of the Filipino population, in particular those nutritionally-at-risk, the DOST-FNRI promotes the commercial production and distribution of their Enhanced Nutribun technology in a series of virtual trainings. SIR EZER and Maestra Panaderia belong to the Batch 16 of trainees.

Participant-firms were primed in Food Safety, Good Manufacturing Practices, and taught on how to produce the ENSV and squash puree during the three-day training.

Both firms expressed their appreciation to the DOST-FNRI and DOST-Cavite for the support and opportunity given to them as one of the licensees of ENSV. To Ms. Leadina T. Monzon, owner of Maestra Panaderia, a healthy community, is a symbol of a prosperous nation. Meanwhile, for Mr. Eliezer Alvez Mendoza, the training was very informative and helpful in producing nutritious, safe and delicious varieties of breads, "We become more aware of the importance of exact and accurate measurement of ingredients to assure nutrition and improve taste and appearance of bread, particularly the Enhanced Nutribun. We also become more attentive to safe and sanitary baking processes. Finally, we also see the necessity of updating our baking equipment to cope with the fast and efficient mass production. Thanks so much to DOST-FNRI."

Both firms successfully produced ENSV based on the formulation given by the DOST-FNRI, and are expecting to start their production after the training.(DOST)

## New Manila Boystown Complex Building Underway

"Mas maganda po sana kung mai-register niyo na rin yung anak niyo kahit 5 years old na siya. Huwag na antayin na 14 years old kasi di natin masasabi kung kailan nila kakailanganin yung national ID (It's better to register your kids even if they are 5 years old. Don't wait until they are 14 years old because we can't say when we will be needing the national ID)," Pagador said in an interview over DZBB.

Pagador said the PSA will eventually incorporate and integrate the national ID into processes and databases of other government agencies.

"Mayroon kaming mga programa na eventually i-integrate natin yung ibang systems ng gobyerno. Makatulong ang national ID halimbawa sa enrollment ng bata. Maraming mga benepisyo ang national ID (We have a program that will eventually integrate this to other systems of government. The national ID can help, for example, with the enrollment of kids. The national ID has a lot of benefits)," she added.

Pagador said senior citizens are also encouraged to get their national IDs despite their age.

She said the PSA is conducting house-to-house registration for seniors and persons with disabilities who are not physically able to register in designated hubs.

"Mayroon naman po ginagawa na programa ang Philsys na pinupuntahan na rin minsan sa mga bahay-bahay lalo na kung may mga kababayan na di po makalabas because physically they are unable to (The PhilSys has a program where house-to-house visits are being conducted for those who are physically unable to)," she said.

She noted that PSA started conducting house-to-house visits during the onset of the

Covid-19 pandemic. Meanwhile, she expressed confidence in achieving their goal of issuing a total of 50 million PhilIDs by end of 2022.

Of this figure, 30 million will be physical IDs while the remaining 20 million will be digital IDs.

"Kakayaning naman po natin 'yun. Piniprepare lang po namin yung iba pong detalye para ma-ensure na once na i-roll out itong ID, smooth po ang aming pagdeploy sa mga registration centers. Hindi po tayo magke-create ng mahabang pila para sa dun sa mga kababayan natin na excited magkaroon ng ID (We will be able to do it. We are just preparing other details to ensure that our deployment to registration centers will be smooth once these are IDs rolled out. We will not create long lines for our countrymen excited to receive their digital IDs)," she said.

As of Aug. 19, 72 million Filipinos have registered to PhilSys.

The PSA has delivered a total of 15.3 million national IDs across the country.

President Ferdinand "Bongbong" Marcos Jr. earlier directed the PSA to issue 30 million PhilIDs by the end of 2022 and register 92 million of the country's population in the PhilSys by mid-2023.

Under Republic Act 11055 or the PhilSys Act, the PhilID shall be accepted and recognized for government and private transactions, and shall be considered as an official and sufficient valid proof of identity for all Filipino citizens and resident aliens.

The PSA is the implementing agency responsible for the overall planning, management, and administration of PhilSys, the government's central platform for all citizen and resident aliens of the Philippines, according to RA 11055. (PNA)

## Slope Protection Underway along Alaminos-Bolinao Road in Pangasinan



Motorists traversing Alaminos-Bolinao Road in Bani, Pangasinan will soon have safer travels with the ongoing road improvement works by The Department of Public Works and Highways (DPWH).

According to DPWH Region 1 Director Ronnel M. Tan, the slope protection project that would prevent landslides in Barangay Tjep is now

halfway done and is set for completion by January 2023.

“The ongoing project is intended to make the critical slope along Alaminos-Bolinao Road more stable as heavy rains and natural calamities can trigger erosion and pose great risks to motorists,” said Director Tan.

Implemented by DPWH Pangasinan First District Engineering

Office, the project involves the construction of stone masonry and laying out of active wire mesh and erosion control mat.

The P96.5-million asset preservation works funded under the 2022 General Appropriations Act (GAA) also covers the construction of lined canal along the road to ensure proper water flow during heavy rains. (DPWH)

## Paved Road Enhances Mobility in Nueva Valencia, Guimaras



Locals and tourists now reap the benefits of a 2.7-kilometer road paved by the Department of Public Works and Highways (DPWH) in the municipality of Nueva Valencia, Guimaras.

Citing a report from District Engineer Rhodora Nuñal, DPWH Region 6 Director Nerie D. Bueno explained that the road now ensures better access to markets, schools, clinics, and

other commercial establishments, and provides a safer alternate route going to nearby towns and barangays.

With the road upgraded from gravel to concrete, an enhanced travel experience also awaits tourists as it serves as a gateway to popular attractions in the province such as Sun Sea Resort, Rumagangrang Beach Resort, and Yato Island.

Barangays Cabalagnan and Salvacion, the road project also improved socio-economic activities in the municipality by providing an alternate route to Cabalagnan Fish Landing, the main drop-off point for fresh seafood in Nueva Valencia.

Specifically, the said laboratory accreditation programs include Biological Testing and Chemical Testing on foods, waters, and beverages which are

valid until 23 December 2023 and 28 August 2024, respectively. An approved signatory status has been granted to Ms. Shaine M. Fonacier for the Biological Testing while Ms. Agnes C. Morales, Ms. Jasmin C. Hamid, Ms. Maria Teresa A. Pamplona, and Ms. Ma. Lorelie P. Dorado for the Chemical Testing.

One of the main benefits of being an ISO/IEC 17025:2015-accredited is that the laboratory will gain international recognition for its commitment to quality, competency, and reliable results. It is an objective way to assure the customers that the laboratory has the technical competence to provide reliable and accurate test results. This serves as an unbiased guarantee that the lab is performing at its highest level. It demonstrates that the laboratory ensures

that the required quality levels and the satisfaction of the customers' needs are met.

RSTL has successfully transitioned from ISO/IEC 17025:2005 to the 2017 version in 2021. The International Laboratory Accreditation Cooperation (ILAC) is an organization promoting international arrangements between member accreditation bodies based on peer evaluation and mutual acceptance to develop and harmonize laboratory and inspection body accreditation practices and to fully implement this new standard from the date of its

publication. At the end of the transition period, laboratories not accredited to the ISO/IEC 17025:2017 will not be allowed to issue endorsed test reports and will not be recognized under the ILAC MRA terms.

The RSTL offers analytical testing services for water, wastewater, foods, feeds, and others such as fertilizer and hand sanitizers through its laboratory units: Chemical Laboratory (Chem Lab), Halal Verification Laboratory (HVL), and Microbiological Laboratory (Micro Lab). The Chem Lab and the HVL, operated by three registered chemists and four registered

chemical technicians, offer physico-chemical testing on food, water, and other matrices and shelf-life testing of food. The Micro Lab is operated by a food technologist, a registered microbiologist, and a biologist, and offers microbiological testing for food and water. RSTL is supported by a customer relations officer (CRO) and two laboratory aides.

Region 8 Director Allan S. Borromeo, Secretary Manuel M. Bonoan said that Phase 1 involves the construction of a two-lane, 6.7-meter wide paved road spanning a total of 259.5 meters, 719.9-meter long riprap, and the installation of 27 solar LED lights, costing P31.76-million.

The entire road project will be 1.19 kilometers long when completed, with a 1,270-lineal meter drainage structure and 8,128 square meters of slope protection.

Scope of works also include a 385-meter embankment and 44

reinforced concrete pipe culverts to allow water to flow freely, given that the area is situated along a rice field.

This multi-year project will serve as the main road for locals and tourists once a portion of Daang Maharlika, which is part of the Civil Aviation Authority of the Philippines (CAAP) jurisdiction is closed.
