

Citing a report from DPWH Unified Project Management Office -Buildings Management Cluster, DPWH Secretary Manuel M. Bonoan said that the ongoing six-storey building project with a gross floor area of 8,608 square meters is now 38 percent accomplished.

"This new PAG-



ASA building will be able to provide a conducive office facility for our scientists, which they deserve considering their significant role for the protection of life and property," said Secretary Bonoan.

When completed, the building will also have an auditorium and additional rooms to comfortably accommodate personnel of the official weather bureau.

The project's scope works includes a of reinforced concrete foundation and building frame from ground floor to the sixth floor with roof deck, dry wall, masonry walls, architectural and water proofing works, curtain wall façade, mechanical works, plumbing and sanitary works, drainage system, and electronic works for a total cost of P269 million. drastically because of the pandemic," she said.

She noted that these sacrifices include their resilience after storms, earthquakes, floods, and other calamities, even those teachers in remote areas.

"Hindi po biro ang mga hamon na hinaharap ng sektor ng edukasyon ngayon. Alam ko ang hirap, pagod, at mga sakripisyo ng mga guro nasa public school man o nasa private school, lalong-lalo na ang mga nagsisilbi sa mga malalayo at liblib na lugar (The challenge faced by the education sector is not that easy. I know the teachers' hardships, exhaustion, and sacrifices, whether in public schools or private schools, most especially those serving in far-flung and remote areas)," she added.

Duterte said honoring teachers is also of personal value, as she believes that their role is very vital for preparing the Filipino youth.

"My great grandmother, Fortunata Gonzales-Roa, served as a public school teacher at the Cabadbaran South Central Elementary School in Cabadbaran, Agusan del Norte for many years. The mother former President of Rodrigo Duterte, our lola, Soledad Roa Duterte, was an educator herself who put up a school for Lumad children in Davao City when she was still alive. And, as a child, I could still remember the many times I sat at the table with my mother, Elizabeth, to check the test papers of her students in the Philippine Women's College in Davao," she recalled.



New Concrete Bridge Connects Zamboanga City to Other Areas



Residents and tourists travelling to the Zamboanga City proper are now benefitting from the new Bangayan Bridge constructed by the Department of Public Works (DPWH). According to

DPWH Region 9 Director Cayamombao D. Dia, the construction of the Bangayan parallel bridge along Zamboanga City-Labuan-Limpapa Road is crucial as it is one of the bridges linking the city to Zamboanga del Norte.

Implemented by DPWH Zamboanga City District Engineering Office, the two (2) way Bangayan Bridge spanning 30 lineal meters now has a widened approach of 4-linear meters. The P37-million

project also involved road widening approach of 178-linear meters to accommodate the growing number of motorists traversing the national road.

"The completion of Bangayan Bridge has helped improve the mobility of goods and services between Zamboanga City and Zamboanga del Norte, aiding in the economic recovery of the province," added Director Dia.(DPWH)

Upgraded Iloilo-Capiz Road Now Safer and Convenient for Motorists



Department The of Public Works and Highways (DPWH) has completed road improvement works along Iloilo-Capiz Road (New Route) in Leganes, Iloilo to facilitate smoother and safer travel between provinces in Western Visayas.

Costing P72 million, the project involved asphalt overlaying of a 4-lane, 3-kilometer concrete road section with provision of reflectorized thermoplastic pavement markings.

Citing reports from OIC-District Engineer Mario G. Soriano, DPWH Region 6 Director Nerie D. Bueno explained that asphalt overlay restores the smoothness and improves driving surface during travel, while markings pavement and solar studs enhance roadway delineation and improve visibility to prevent road accidents.

Locals and visitors now have better access going to northern Iloilo towns and various establishments as well as tourist destinations in the neighboring provinces of Capiz and Aklan, thanks to improved land transportation, which will help promote socioeconomic development in the region.

DPWH Iloilo 4th District Engineering Office implemented the project with funding from FY 2022 Regular Infrastructure Program. (DPWH)

Anong bahagi ng halaman ang ginagamit bilang gamot, at paano ginagamit ang mga ito?

Ano ang mga sakit at kondisyon na maaaring magamot ng Luya?

5. Ubo. Iniinom din ang salabat, o tsaa na mula sa pinaglagaan ng bungang-ugat ng luya para sa ubo.

6. Sore throat. Ang pananakit ng lalamunan ay maaari namang matulungan ng pag-inom sa salabat pati na ang pagnguya sa mismong ugat ng luya.

7. Pasa. Ang pagpapasa naman sa balat ay maaaring tapalan ng dinikdik na dahon ng luya.

8. Kawalan ng gana sa pagkain. Mahusay daw na pampagana ang pagkain sa luya na sinawsaw sa asin.

9. Pagsusuka. Pinakakain din ng bungang-ugat ng luya ang taong nakararanas ng pagsusuka at pagliliyo.

10. Pamamanas sa katawan. Ang paginom naman sa katas ng ugat ng luya ay mabisa para mawala ang pamamanas o ang pagkakaroon ng tubig sa katawan.

DPWH, NEDA ATTEND MEETING OF CONGRESS COMMITTEE ON FLAGSHIP PROGRAMS AND PROJECTS



Key individuals from the Department of Public Works and Highways (DPWH) and National Economic and Development Authority (NEDA) attended the special briefing requested by the Committee on Flagship Programs and Projects of the House of Representatives.

Upon instruction of DPWH Secretary Manuel M. Bonoan, Senior Undersecretary Emil K. Sadain on Wednesday, September 7, 2022 provided a briefing to the committee members on the status of the country's flagship

programs and projects. This came after this new regular committee in the 19th convened Congress for its organizational meeting and adoption of internal rules of procedure physically presided by Senior Vice Chairperson Maria Carmen S. Zamora at Conference Rooms 3 & 4 of RV Mitra Building of Congress in the absence of Chairperson Congressman Claude P. Bautista.

The Committee on Flagship Programs and Projects has jurisdiction over matters directly and principally relating to the identification, prioritization, implementation, monitoring, evaluation and review of highlystrategic infrastructure programs and projects.

S e n i o r Undersecretary Sadain, Chief Implementer of Flagship Projects under the Build Build Build Program in the last eight (8) months of President Rodrigo Duterte administration, provided members of the committee present at the physical meeting virtually and thru zoom videoconference c o m p r e h e n s i v e information and status

of the country's flagship programs and projects.

R e c o g n i z i n g that the backbone of an economy is its infrastructure, President Ferdinand Romualdez Marcos Jr. has earlier declared in his first State of the Nation Address on July 2022 that the infrastructure program of the Duterte administration must not only continue but, wherever possible, be expanded to keep the momentum.

Under the administration of President Marcos, the government aims to Build Better More infrastructure as it intend to prioritize the construction of better farm-to-market roads and supporting irrigation development programs that will agricultural enhance production for food security; development of more roads leading to tourism destinations to facilitate revival, recovery, and resiliency of the tourism industry from the devastating effects of the Covid-19 pandemic; and building of resilient schoolbuildings with comfortable and spacious classrooms towards the delivery of quality education, said Senior Undersecretary Sadain.

Senior

Undersecretary Sadain reported that there are about 119 infrastructure flagship projects (IFPs) prioritized as gamechanging urgently needed projects of national significance and considered subset of the Build Build Build program, the banner program for accelerating i n f r a s t r u c t u r e development.

Of the 119 IFPs implemented by 17⁻ agencies, 76 are transport and mobility sector, 15 urban development sector, 11 water resources three sector, (3) and energy power sector, 10 information communication technology sector, and four (4) health sector.

Five (5) of the 15 infrastructure flagship projects completed ÎFPs are under DPWH portfolio namely Bonifacio Global City-Ortigas Center Project; Link Road Binondo-Intramuros Bridge and Estrella-Pantaleon Bridge under China grant bridges; improvement of remaining sections Pasig along River from Delpan Bridge to Napindan Channel; programme for the support to rehabilitation and reconstruction of Marawi City and its surrounding areas; and flood risk management project (FRIMP) in Cagayan, Tagoloan, and Imus Rivers.

In addition to completed IFPs are two (2) projects partially open or turnover for operation at the end of June 2022 with people now reaping the project benefits including the Samar Pacific Coastal Road Project in Eastern Visayas and Malitubog Maridagao Irrigation Project - Stage 2 in municipalities in Province of Cotabato and Maguindanao while 10 more projects will be completed towards end of the year 2022.

The meeting livestreamed on the official facebook page of the House of Representatives was attended physically by Congressman Nelson L. Dayanghirang, Congressman Joseph S. Tan, and Committee Secretary Ms. Cristina S. Sulaik.
