MANILA - The Department of Trade and Industry's (DTI) mandate covers everything that will protect consumer welfare, from probing unhealthy instant noodles to promoting English proficiency in the workplace.

During the budget hearing on Monday, Senator Raffy Tulfo asked the DTI to help other government agencies in ensuring that food products sold to the public are safe, like instant noodle products with high sodium content.

even if it is not your responsibility)," Tulfo told DTI Secretary Alfredo Pascual.

Pascual said he will refer the issue to the Department of Health (DOH). Republic Act (RA) 10611 or the Food Safety Act states that the DOH and Department of Agriculture are mandated to assess the risk of food and agricultural products available in the market.

Experts say instant noodles are usually low in calories, fiber, protein, and micronutrients, but high in fat, carbohydrates, and sodium. Regular consumption is associated with obesity, digestive problems, heart disease, diabetes, and stroke, health experts have warned.

After DTI's budget presentation, Pascual was also asked by Senator Pia Cayetano for the feedback of foreign investors, especially in the business process outsourcing industry, on Filipinos' English language proficiency. Cayetano cited data from 2013 to 2020 that the English proficiency of Filipinos gradually dropped.

Pascual admitted that the DTI had observed the decline, especially among the youth.

"If you ask us what we're doing, we are reminding and alerting our educational institutions of the expectations of the foreign investors with respect to the English proficiency of our workers. That's our advantage and we need to make full use and really develop that advantage further," he said. The DTI proposed a budget of PHP18.149 billion but was approved just PHP8.442 billion under the 2023 National Expenditure Program.

Subcommittee on Finance chair Senator Mark Villar assured that the DTI and its attached agencies will have an efficient 2023 budget to effectively implement the priority programs of the administration. "It is my hope that the DTI and its attached agencies will achieve its goals and programs as we begin this new administration," Villar said. (PNA)

DPWH Improves Accessibility in Tarlac with Bridge Widening, Bypass Road Construction

The Department of Public Works and Highways (DPWH) is fast-tracking the construction of two (2) projects to facilitate better and efficient transportation in the province of Tarlac.

DPWH Regional Office 3 Director Roseller A. Tolentino reported to DPWH Secretary Manuel M. Bonoan and Undersecretary Roberto R. Bernardo that the P305.91-million parallel bridge to the existing San Francisco Bridge and the P105.6-million



Concepcion-Mabalacat Bypass Road are currently in the works under the implementation of the regional office's Construction Division.

According to Director Tolentino, the widening of San Francisco Bridge along Concepcion-Capas Road is a multi-year project that started in 2019.

For the its initial funding, a total of P110.98 million was released for the construction of the parallel bridge substructure consisting of 14 bored piles and seven (7) coping beams, approach slabs, and the partial construction of six (6) steel girders with a 50-meter span length.

Director Tolentino bared that the implementation of the bridge widening project was temporarily halted in 2020 due to the COVID-19 pandemic.

The construction activities resumed in 2021 with an additional P146.68-million allocation from the national budget

already posted 95.97 percent completion based on the total fund released as of September 2022.

Targeted for full completion in the latter part of the year 2022, about 15,000 vehicles traveling daily along the Concepcion-Capas Road are expected to benefit from the newly-upgraded San Francisco Bridge.

Meanwhile, the construction of a new bypass road providing an alternative connection between the provinces of Tarlac and Pampanga is also underway.

The Concepcion-Mabalacat Bypass Road project involves the excavation, embankment, and paving of 9.9 lineal kilometers of roads starting on the Tarlac side.

Since civil works started in June 2022, the project has recorded an accomplishment rate of 30.12 percent .

Director Tolentino said that faster travel time between the towns of Mabalacat, Pampanga and Concepcion, Tarlac is seen with the bypass road project completion, which is slated in March 2023.(DPWH)
