DOLE vows to upskill workers as more investors in PH seen



MANILA – The Department of Labor and Employment (DOLE) is boosting efforts to ensure that the Philippines has a pool of highly skilled and educated workforce as more foreign investors decide to do business in the country.

In a Bagong Pilipinas episode aired Saturday, Labor Secretary Bienvenido Laguesma bared that the DOLE is providing workers with opportunities to learn additional skills to resolve the country's skills-job mismatch problem.

430-yr-old Cavite museum houses new GomBurZa sculpture

CAVITE CITY - The lives of the three Filipino Catholic priests, Mariano Gomez, José Burgos, and Jacinto Zamora (GOMBURZA), cut short at the hands of their executioners during the Spanish rule but the impact of their martyrdom last forever.

These were the words of Justice Secretary Jesus Crispin Remulla when he unveiled the GOMBURZA sculpture inside the dungeon of the 430-year-old Philippine Navy Museum in this city late Thursday afternoon.

The bronze eight feet tall sculpture was created by Architect Flordeliza Villasenor.

his In speech, Remulla reminisced the heroics of Fr. Gomez, the pride of Bacoor, Cavite; Fr. Burgos a native of Manila; and Fr. Zamora from Marikina, who

were all sentenced to death and died by garrote on February 17, 1872, in Bagumbayan (now Luneta Park) by Spanish colonial authorities after being accused of subversion arising from the 1872 Cavite mutiny.

The three priests gave up their lives which contributed to the freedom enjoyed by every Filipino today, the secretary said.





He said upskilling of workers must be industry-led as well as demand and market-driven so they can find employment that suits their skills.

With the expected influx of foreign investors, the Department Energy (DOE) is also improving access to cheap and stable energy supply that could sustain manufacturing industries that create jobs. Energy Undersecretary Felix William Fuentebella said the DOE is sticking to its target of a 35 percent share of renewable energy (RE) in the power generation mix by 2030 and a 50 percent share by

He described the shift to renewable energy as timely due to high fuel prices that burden powergenerating plants.

Fuentebella likewise expressed optimism that the country's offshore potential is "so ideal" and can sustain its future energy demand.

Currently, he said that part of the government's initiative to lower electricity prices is the diversification of energy sourcing.

He said the government is also educating the public on energy efficiency and conservation. (PNA)


target to start phase 2 of the construction for the CAVITEX C5 Link Segment 2 this Q1 of 2023 and aims to open it to the public before the end of the year.

Meanwhile, construction of Segment 3-B from Sucat to Rodriguez (RSG Subdivision), according to the latest project timeline of CIC, is set to begin in the third quarter of the year.

CÁVITEX C5 Link project is a 7.7-kilometer 2x3 lane expressway that will connect CAVITEX R1 to C5 Road in Taguig. It is expected to serve 40,000 vehicles per day: reducing travel time to Makati and Taguig from Parañaque City, Las Pinas Ĉity, and Cavite Province by fortyfive (45) minutes; and decongesting traffic in Metro Manila.

Aside from CAVITEX and its C5 Link Segment, the MPTC's tollways portfolio includes the concessions for the Cavite-Laguna Expressway (CALAX), North Luzon Expressway (NLEX), the Subic-Clark Tarlac Expressway (SCTEX), the NLEX Connector Road, and the Cebu-Cordova Link Expressway (CCLEX) in Cebu.
