PBBM TOGETHER WITH DPWH EXEC ASSESS BUGAAN BRIDGE DAMAGE IN LAUREL, BATANGAS



President Ferdinand "Bongbong" Marcos Jr., along with Department of Public Works and Highways (DPWH) Secretary Manuel M. and DPWH Bonoan Region IV-A Assistant Regional Director Ioel F. Limpengco, recently conducted a site inspection of the damaged Bugaan Bridge in Laurel, Batangas.

The four-lane, Bugaan Bridge spanning 38.5 meters, suffered extensive damage during Severe Tropical Storm Kristine, with damage costs of 120 million In response, pesos. DPWH officials have proposed constructing a bridge with an extended span of 50 meters. The proposed four-lane bridge is expected to cost approximately 150 million pesos. Slope protection measures are also necessary to

prevent future landslides and erosion in the surrounding area, with an estimated cost of 150 million pesos.

DPŴH Secretary Bonoan briefed President Marcos on immediate actions, including the construction of a temporary bridge. This spillway structure will serve as an alternative crossing point for residents and vehicles while the main bridge undergoes reconstruction. DPWH has also identified an alternate route through Laurel-Canyon Woods Road via Bugaan West, which will facilitate travel between affected areas and help ease congestion around the damaged site.




