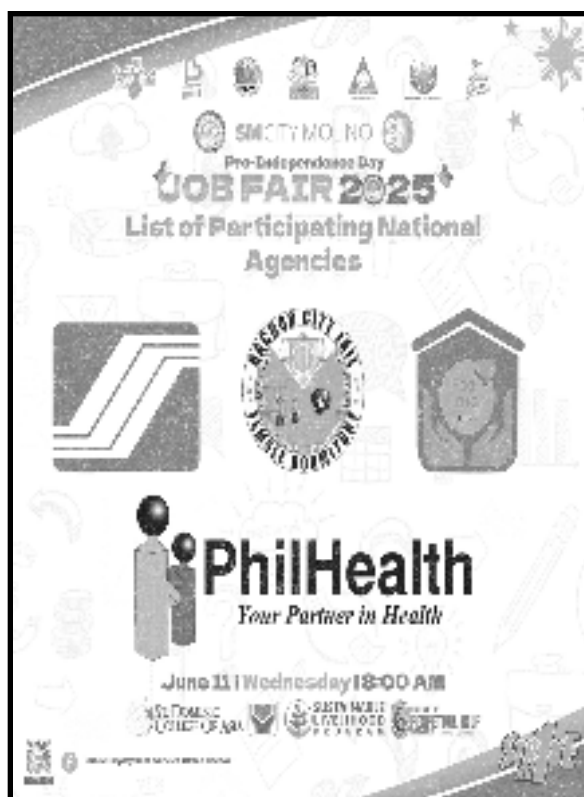

The strength to succeed



Taking every opportunity that comes her way, Ramona Manlangit has dived into different businesses to provide income for her family, even while at home.

Ramona Manlangit from Tayabas, Quezon, finds it extremely challenging to grow up without her parents' guidance. She was only four years old when her mother passed away while giving birth to their youngest sibling. Her father, in a state of depression, died less than a year later. As a result, she and her three siblings were raised separately by their relatives. But even though they are raised apart, their bond remains strong.

After graduating high school, her eldest sibling married a foreigner and worked abroad, supporting their school expenses. With their combined efforts, they all graduated from high school.

When she turned 22, she moved into her husband's house, living with her in-laws. On the other hand, her husband began working as a seaman, though

he would return home occasionally.

Building a business from home

Motherhood gave her a new motivation to earn from home while caring for her child. This desire marked the start of her business journey. She became a load agent while selling frozen foods and rice at home. With this kind of business, she eventually started a sari-sari store.

As their store thrived, the couple decided to modify the place to become their home while maintaining the store in front. She obtained PHP 10,000.00 from CARD, Inc. (A Microfinance NGO) to provide additional capital for her business.

In 2023, she invested in a Piso Wi-Fi machine, recognizing that many people were becoming reliant on technology and digital services.

A year later, she established a fried

chicken and sisig food stall—street style—which became popular even among students because of its affordable price. She personally marinated the chicken, whereas her brother, who had been a chef at a restaurant for 10 years, prepared the sisig.

In August 2024, she used a loan from CARD, Inc., to buy a coffee vending machine to pair with her Piso-Wifi business. It was a great combination, allowing customers to enjoy a cup of coffee while browsing the internet.

"Always consider the needs and wants of the people around you. In that way, you can tailor your business to meet their needs better," she said when asked how she came up with her business ideas.

Ramona, who has been a client of the institution for more than a year, has reached a loan amount of PHP 100,000.00, a testament

to her good repayment record.

"I used to think that microfinance was just lending, but after becoming a client, I learned more than that. In addition to loans, the institution also offers insurance, savings, and other products, which motivated me to join," she said.

Her advice to her fellow clients and those planning to become one is to be responsible. Maintaining a good repayment record makes securing a loan from the institution easier when needed.

There is still a long way to go, but she wanted to expand her sari-sari store into a mini grocery store offering rice products. Ramona shared, "If my husband decided to come home for good and stop working as a seafarer, I want him to come home to something we built together."

Takoyaki Making Training Brings Livelihood Opportunities to Farmers and OFWs



In its continuous effort to promote sustainable livelihood programs, the Office of the Provincial Cooperative Development Officer (OPCDO), through its Livelihood Division, successfully conducted a Takoyaki Making Training on June 3, 2025, at the covered court of Amadeo, Cavite.

More than 30 participants from the province composed of farmers and OFWs took part in the hands-on training facilitated by Ms. Venus Romerosa, OPCDO Outsource Trainor, which aimed to equip residents with skills that could be turned into income-generating ventures. The activity is part of the Provincial Government of Cavite and OPCDO's commitment to empower local communities by providing practical livelihood opportunities.

The training covered the basics of preparing and cooking takoyaki – a popular Japanese street food – as well as tips on sourcing affordable ingredients and managing a small food business. Participants expressed appreciation for the engaging and informative session, which not only enhanced their culinary skills but also opened possibilities for starting their own food stalls or home-based businesses.

Ang alugbati ay isang halamang gumagapang na kalimitang nakikitang tumutubo sa kahit saan. Ito ay may mapupulang baging o sanga at hugis puso na dahon. Ang bunga ay maliliit na bilog na parang paminta na kulay lila. Nagkukulay ang bunga nito na mapula o kulay lila kung kaya't madalas itong ginagamit bilang kolorete sa mukha.

Ano ang mga sustansya at kemikal na maaaring makuha sa Alugbati?

Maaaring gamitin bilang gamot ang ilang bahagi ng halaman tulad ng:

Ugat. Ang katas ng ugat ay kinukuha sa pamamagitan ng pagdikdik dito o kaya at sa paglalaga nito.

Dahon. Ang mga dahon ay karaniwang nilalaga o kaya ay kinakatasan upang makuha ang malapot na dagta.

Baging o sanga. Kinukuha rin ang malapot na dagta mula sa mga baging at sanga ng halaman sa pamamagitan ng pagdikdik dito.

Ano ang mga sakit na maaaring magamot ng Alugbati?

Ayon sa mga pag-aaral at nakagawian ng ilan, ang ilan sa mga sakit na maaaring malunasan sa pamamagitan ng paggamit sa halamang alugbati ay ang sumusunod:

1. Buni. Ang pagpapahid ng malapot na dagta ng dahon at mga sanga ng alugbati ay makatutulong sa mas mabilis na pagpapagaling sa buni sa balat.

2. Pagtatae o disinterya. Ang pag-inom sa malapot na dagta mula sa dahon at mga sanga ng alugbati ay makagagamot daw sa pagtatae o disinterya.

3. Altapresyon. Maaaring ipainom ang pinaglagaan ng dahon ng alugbati sa taong dumaranas ng pagtaas ng presyon ng dugo.

4. Pagsusugat. Makatutulong ang katas ng dahon ng alugbati na hinalo sa mantikilya sa mabilis na paggaling ng mga sugat sa balat. Maari ring itapal ang mga tinadtad na dahon sa apektadong balat.

5. Pagtatagihawat. Ang dagta ng alugbati ay mainam para hindi lumaki ang mga tagihawat sa katawan.

6. Ulcer. Ang pagkakaroon ng ulcer sa sikmura ay maaaring mabilis na mapagaling ng pag-inom ng pinaglagaan ng dahon ng alugbati.

7. Pananakit ng sikmura. Ang pinaglagaan ng ugat at mga sanga ng alugbati ay mainam para sa pananakit ng sikmura.

8. Pananakit ng ulo. Ang malagkit na dagta na mula sa mga dahon at sanga ay pinapahid sa ulo para mawala ang pananakit na nararanasan.

Isinagawa ng PhilHealth Regional Office IVA ang serye ng oryentasyon ukol sa group enrollment na dinaluhan ng mga HR practitioners at kinatawan ng mga LGUs, National Government Agencies at iba pang pribadong institusyon.

Ang Group Enrollment Program o GEP ng PhilHealth ay isang alternatibong paraan para sa mga organisadong grupo, National Government Agencies na mapadali ang pagbibigay ng PhilHealth coverage sa mga Job Order Contract Workers, seasonal employees o ang mga walang tinatawag na employer-employee relationship sa ilalim ng batas.

Batay sa PhilHealth Circular 2017-0008, mandatory ang coverage ng mga indibidwal na directly hired Job Orders (JOs) at Project Based Contractors (PBCs) sa gobyerno bilang miyembro ng PhilHealth sa ilalim ng Informal Economy. Sa ilalim din nito, binibigyan ng kapangyarihan ang mga employers na magbawas at mag-remit ng premium contributions nga mga naturang empleyado bilang Individually Paying

Members o Self Earning Individuals sa ilalim ng Group Enrollment Scheme.

Ang mga Local Government Agencies, National Government Agencies at pribadong institusyon na nagpakita ng intensyon na sumali sa implementasyon ng Group Enrollment Program ay kinakailangan na magsumite ng mga sumusunod na dokumento:

1. Pirmadong Memorandum of Agreement or Letter of Commitment at
2. Non-Disclosure Agreement

Matapos, makapagpa-rehistro, magi-isyu ng PhilHealth Organized Group Number (POGN) na magsisilbing pagkakakilanlan ng kanilang grupo. Ang POGN din ang gagamitin sa pagpaparehistro o renewal ng mga taong nakalista sa programa at pagbabayad ng kanilang premium contributions.

Lahat ng Pilipinong indibidwal na hindi kasapi ng National Health Insurance Program ay maaaring mai-enroll sa Group Enrollment Program na hindi limitado sa mga sumusunod:

1. Contract of Service (COS), Job order and Project-based personnel

2. Miyembro ng mga microfinance institutions at iba pang organisadong grupo

3. Self-earning individuals

4. Professional practitioners

5. LGU constituents na nabibilang sa may mababang sahod, barangay health workers, nutrition scholars at iba pang mga nagtatrabaho ng boluntaryo sa barangay

6. Estudyante na edad na 21 at pataas

Sa pagpaparehistro, ang mga group partners ay kinakailangang magsumite sa PhilHealth ng listahan ng kanilang nais isali sa programa kalakip ang napunan na PhilHealth Member Registration Form (PMRF) at mga kaukulang dokumento.

Sa mga kaso na may mga indibidwal na mag-withdraw ng kanilang pagiging miyembro, ang mga group partners ay dapat agarang ipahayag ang kanilang pag-withdraw at magpasa ng Group Enrollment Withdrawal Form.

Ang premium contribution sa ilalim

ng Group Enrollment Program ay naaayon sa PhilHealth Circular 2020-0005 na base sa idineklarang kita ng miyembro sa pamamagitan ng group partner.

Ang mga group partners ay regular na ebi-bill sa pamamagitan ng pagbibigay ng Statement of Premium Account (SPA) na maaaring monthly, quarterly, semi-annually at annually. Ito ay maaaring bayaran sa mga Local Health Insurance Offices o Accredited Collecting Agents na awtomatikong papasok sa indibidwal account ng mga miyembro.

Ang mga indibidwal na gagamit ng benepisyo ng PhilHealth ay bibigyan ng Certificate of Premium Payment na maaaring maging batayan kung updated ang kanyang kontribusyon sa PhilHealth.

Sa kasalukuyan, mayroon nang 42 group partners at 1,210 miyembro sa ilalim ng Group Enrollment Program.

Sa mga grupo or organisasyon na nais mapabilang sa GEP, maaaring makipag-ugnayan sa alingmang tanggapan ng PhilHealth sa inyong lugar.

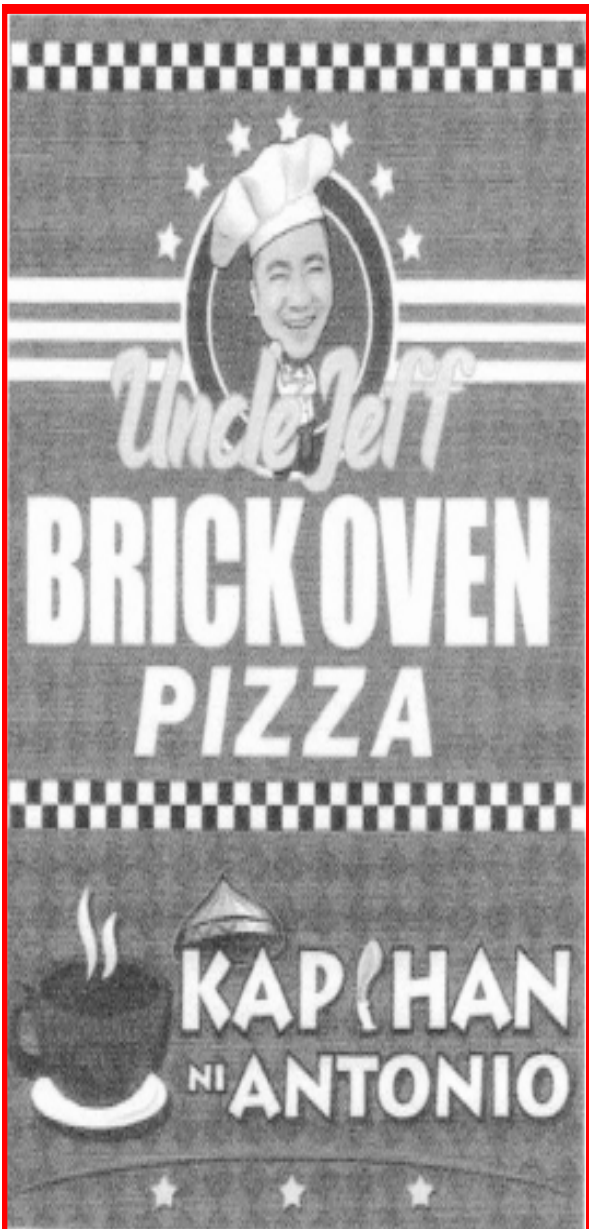

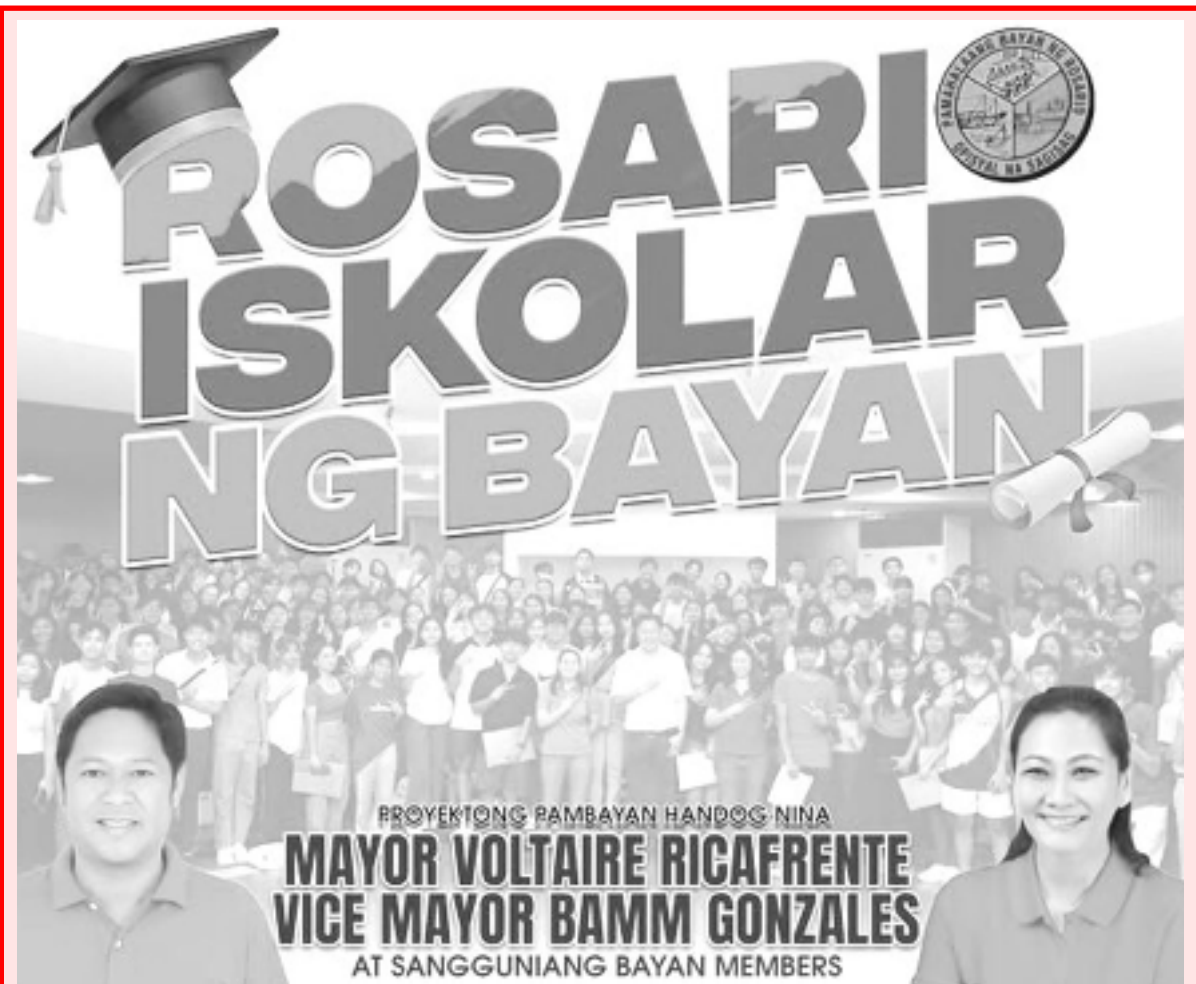
