



Bringing Essential Care to Mendezeños in Brgy. Anuling Cerca 2



Ano ang mga sustansya at kemikal na maaaring makuha sa *Common name: Anonas (Tagalog); Custard Apple (Inglés)*

Ang iba't ibang bahagi ng halamang anonas ay maaaring makuhanan ng maraming uri ng kemikal at sustansya na maaaring may benepisyo sa kalusugan:

Taglay ng balat ng kahoy ng anonas ang anonaine at 5-6 dioxymethylene-aporphine. Mayaman din ito sa tannic acid.

Mayroon namang dextrose at levulose ang bunga ng anonas

Anong bahagi ng halaman ang ginagamit bilang gamot, at paano ginagamit ang mga ito?

Maaaring gamitin bilang gamot ang ilang bahagi ng halaman tulad ng:



Scientific name: *Annona reticulata* Linn.; *Annona humboldtiana* Kunth; *Annona humboldtii* Dunal

Dahon. Ang dahon ay karaniwang ginagamit na pantapal sa apektadong bahagi ng katawan. Ito ay pinapadaanan sa apoy bago ipantapal. Dinidikdik din ito upang magamit na pantapal.

Balat ng kahoy. Karaniwan namang nilalaga ang balat ng kahoy para mainom ng may sakit.

Ugat. Maaari ding ilaga ang ugat para mainom at makagamot sa ilang kondisyon.

Bunga. Ang hilaw na bunga ng anonas ay mabisa ding gamot para sa ilang karamdaman.

Ano ang mga sakit at kondisyon na maaaring matulungan ng Anonas?

With no prior background in candy making, Maricel knew from the start that it would be a challenging journey. Her first attempt at making yema ended with burnt milk, while her next try hardened too much. Resolute, she carefully monitored the heat and stirred the mixture well on her next

try, giving her the perfect consistency she had been aiming for.

Her initial customers were neighbors and co-workers. Earning positive feedback, she gradually expanded and started offering her products to local stores and neighboring communities. She eventually left her job to focus entirely on her candy business. What began as a side hustle soon became her primary source of income. As the business flourished, she introduced new flavors, such as graham balls and pastillas, to offer her customers more options.

As digitalization advances, she embraces social media to promote her business. Additionally, she offers online banking options for customers who prefer cashless transactions. She prioritizes her products' excellent quality and cleanliness to keep her customers coming back. Her business holds a sanitary permit from the local municipality, ensuring standards are


