For more than three decades, the sun-kissed tan skin of Alexander Amado from Atimonan, Quezon, tells a silent story of the long hours he spent under the blazing sun, diligently drying fish to make a living.

He was a fresh graduate when he started making and selling dried fish. Since it was also his mother's business, he found it easy to get started since he was already familiar with the process. Although Alexander earned a Bachelor of Science in Education (BSED), he found greater enjoyment in running a business, so after care-

ful consideration, he set aside a teaching career to pursue his passion for business.

Alexander handles every step of the drying process himself, from buying the fish in the market to cutting, cleaning, seasoning, and laying them out to dry under the sun. He produces around 30 kilos each day, and just six months ago, his nephew started helping with the cleaning, which has made the workload a bit lighter.

Sometimes, he would personally go around the neighborhood to sell dried fish, while oth-

## Stronger Together: CSOs and LGU unite to shape Cavite's governance future

In a united effort to strengthen participatory governance, the Provincial Government of Cavite, through the Office of the Provincial Planning and Development Coordinator (OPPDC), in partnership with the Department of the Interior and Local Government (DILG) Cavite, convened Civil Society Organizations (CSOs) for the Joint Organizational Meeting for Local Special Bodies held at the New Provincial Government Center, Trece Martires City on October 9, 2025.

Provincial Administrator Engr. Gilbert V. Gandia warmly welcomed participants, highlighting the indispensable role of CSOs as vital partners in shaping inclusive and responsive local governance. Engr. Lorna R. Leyran, Provincial Planning and Development Coordinator, led the introduction of members

of the Local Special Bodies, which include the Local Development Council, Local Health Board, Local School Board, and Local Peace and Order Council. She underscored the importance of these bodies as platforms for meaningful collaboration between government and civil society in crafting policies and programs that address community needs.

The meeting featured a series of comprehensive presentations by DILG Cavite officials. LGOO III Niña Norisa C. Maranga discussed the roles and functions of the Local Development Council, followed by LGOO III Maria May M. Ambata, who tackled the Local Health Board, while LGOO II Amiel Dela Rosa elaborated on the functions of the Local School Board. These discussions equipped CSO participants with a deeper understanding of

their active role in local governance structures.

Participants then engaged in an action planning session, where CSOs mapped out strategies to strengthen their involvement and ensure their voices are heard in policy-making processes. Concluding the productive activity, DILG Cavite OIC-Provincial Director Marcial A. Juangco delivered an inspiring message, reaffirming the agency's commitment to empowering CSOs as key partners in development, transparency, and good governance.

Through the joint initiative, the OPPDC and DILG Cavite continue to build stronger linkages between the government and civil society, paving the way for more transparent, accountable, and people-centered local governance in the Province of Cavite.

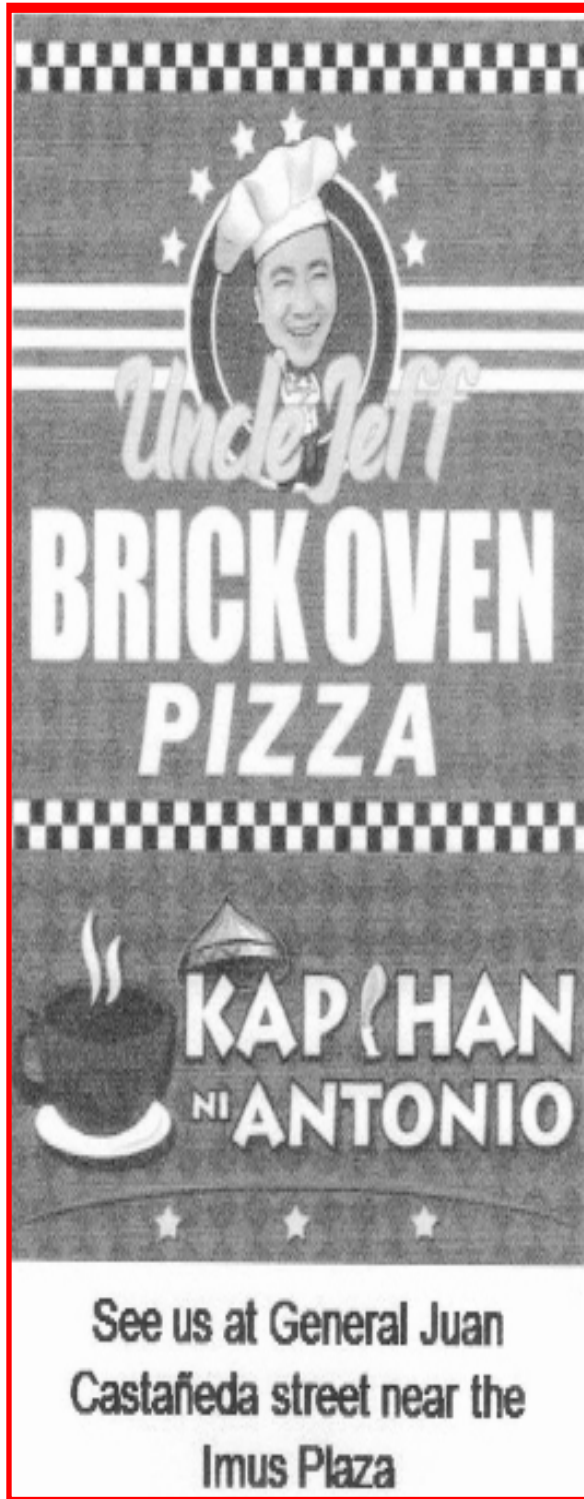

Naaprubahan na sa Kongreso ang ₱100 milyong pondo para sa pagtatayo ng bagong ospital sa bayan ng Naic, Cavite.

Ito mismo ang inanunsyo ni Cavite 8th District Representative Aniela Tolentino sa isang Facebook Live kasama si Naic Mayor Rommel Magbitang kamakailan. Ayon sa kongresista:

“Na-approve na ang budget ng ospital ng Naic — ₱100 million for next year; approved

na sa GAB, sa General Appropriations Bill. So napondohan na ‘yan ng Congress. Official na, may pondo na ang bayan ng Naic para sa ospital.”

Sa pagkakapasa ng General Appropriations Bill, opisyal nang may nakalaang pondo ang pamahalaan para sa pagpapatayo ng Naic Hospital. Inaasahang malaking tulong ito sa mga mamamayan ng Naic at mga karatig-bayan, lalo na sa serbisyong medikal at pangkalusugan.

er times, buyers came straight to his house. His products have reached customers as far as Manila. On good days, he can sell all 30 kilos per day. But on slow business days, he only sells about 10 kilos.

In 2015, when he needed additional capital for his business, his sibling, who was already a client, introduced him to CARD Bank, a micro-finance-oriented rural bank. That marked the beginning of his journey as a client of the institution, which supported him in sustaining his dried fish business.

His biggest strug-

gle in this kind of business is the unpredictable weather, especially during heavy rain and typhoons. It became difficult to dry the fish; hence, sales would drop due to limited production. To keep the income flowing these days, he switches to selling fresh fish at their house.

Reflecting on his experience, he shared, “In this kind of business, aside from capital, it’s hard work and perseverance that truly matter. There is no room for impatience because drying fish takes time and a lot of patience, especially during the rainy season.”

## Mayor Strike Revilla, Nanguna sa Pagsusuri ng mga Estruktura at Paaralan para sa Kahandaan sa Kalamidad



Lungsod ng Bacoor – Bilang bahagi ng inspeksyon si Mayor Strike B. Revilla sa iba't ibang lugar sa lungsod para sa kahandaan sa noong Oktubre 14, sakuna, personal na 2025. Isa sa mga binisita nagsagawa ng mga ay ang Divine Light

Academy sa Town & Country West, Barangay Molino 3, kung saan masusing sinuri ang kahandaan at katatagan ng mga estruktura.

Kasama ni Mayor Revilla sa mga pagbisita ang mga kinatawan mula sa Barangay, City Engineering Office, Bacoor Disaster Risk Reduction and Management Office (BDRRMO) at Bureau of Fire Protection (BFP). Binibigyang-diin ng alkalde ang kahalagahan ng maagap na pagsusuri sa mga paaralan at pampublikong estruktura upang masiguro ang kaligtasan bago pa man tumama ang sakuna. Kabilang sa kanyang mga kasama ay si G. Richard Quion, Hepe ng BDRRMO, at si Engr. Jicky Jutba mula sa City Engineering Office, na nanguna sa mga teknikal na pagsusuri.

Sa Divine Light Academy, personal na nakausap ni Mayor Revilla ang mga mag-aaral at guro, kung saan binigyang-pansin niya ang kahalagahan ng pagiging handa at mapagmatyag. Nagbigay rin ang BDRRMO ng impormasyon hinggil

sa "Go Bags" at mga emergency hotline. Samantala, hinikayat ni Acting City Fire Marshal FSINSP Precious Petalio ang mga paaralan na makilahok sa mga aktwal na pagsasanay sa Strike Fire and Rescue Village.

Bagamat hindi direktang nasa ibabaw ng isang fault line ang Lungsod ng Bacoor, ito ay matatagpuan malapit sa West Valley Fault— isang aktibong fault na dumadaan sa kalapit na mga lungsod gaya ng Muntinlupa at Taguig. Dahil dito, maaaring makaranas ang Bacoor ng malalakas na pagyanig kung sakaling magkaroon ng malaking lindol, gaya ng tinatawag na "The Big One."

Dahil dito, binigyang-diin ni Mayor Revilla ang kahalagahan ng pagiging handa, kahit pa ang Bacoor ay hindi direktang nasa fault line. "Ang kaligtasan ay hindi lang nakasalalay sa lokasyon, kundi sa kahandaan ng bawat isa," ani ng alkalde.

Maliban sa Divine Light Academy, binisita rin ng alkalde at ng kanyang grupo ang ilang mahahalagang lokasyon upang magsagawa ng inspeksyon sa mga pampublikong pasilidad, suriin ang mga umiiral na safety protocols, at tiyakin na may mga maayos na evacuation at response plans, lalo na sa mga paaralan at community centers.

Sa pamamagitan ng mga aktibidad na ito, pinatitibay ng Pamahalaang Lungsod ng Bacoor ang pangako nitong maging isang disaster-resilient na lungsod. # From Fish to Fortune



**Anabell Gibaga, a 50-year-old entrepreneur and proud QSL client of CARD SME Bank from Zamboanga City, exemplifies how determination, passion, and partnership can turn dreams into reality. Alongside her husband, she proves that anything is possible when you commit your heart, mind, and soul to your goals.**

In Talon-Talon, Zamboanga City, a community known for its dried fish trade, lives Anabell Gibaga, a 50-year-old entrepreneur whose journey is deeply rooted in resilience and hard work.

Through dedication and the support she has received along the way, Anabell has transformed the family dried fish venture into a thriving livelihood, proving that with determination and the right opportunities, success is within reach.

Her journey began not with a grand business plan, but with a legacy. "The bulad (dried fish) business was our family's way of living," she shared. It was a livelihood passed down by her parents, a humble venture supported by a single fishing boat and long hours of drying fish under the sun. What began as a means to make ends meet soon evolved into something much bigger.

As the quality of their dried fish gained attention, larger fishing corporations in Zamboanga started to take notice. This marked a turning point. "We shifted from catching to processing. The companies would supply us with the fish, and we'd handle everything else from cleaning to drying to packing,"

she explained. In just 2-3 days, the raw catch would be transformed into high-quality dried fish, boxed and ready for delivery across Cebu, Davao, and other nearby provinces in Zamboanga.

The demand is steady. Customers, both big and small, remain loyal because of the quality and consistency of the products. "Even with stiff market competition, people keep coming back because they trust our product's quality," Anabell said.

But the journey hasn't always been smooth. "Weather is our greatest challenge," Anabell admitted. Rainy days disrupt the fish-drying process, often requiring them to shift to careful fermenting and freezing methods. Despite these setbacks, the business has continued to grow and persevere through every obstacle.

Anabell's dried fish business offers popular varieties like galunggong (mackerel scad), hasa-hasa (short mackerel), tamban (sardinella), and more. Prices range from under PHP 2,600 to PHP 4,000 per box. Customers can purchase in kilos or bulk, depending on their needs. "Our pricing may vary based on the type of fish," Anabell stated.

## PGC EMPOWERS CAVITE FARMERS THROUGH "LIVELIHOOD ON THE GO"

To support the province's agricultural sector and promote value-adding in local produce, the Office of the Provincial Cooperatives Development Officer (OPCDO) spearheaded the "Livelihood on the Go" training on Fruit Processing on October 7, held at the Office of the Provincial Agriculturist (OPA) Compound in Trece Martires City.
